15	Colorado, and Part 2, Article 1, Title 29, C.R.S., encourages and authorizes intergovernmental
16	agreements; and

18	WHEREAS, Section 29-1-203, C.R.S., authorizes governments to cooperate and
19	contract with one another to provide any function, service, or facility lawfully authorized to each;

22	WHEREAS, the City constructed a fiber optic communications system within the
23	City consisting of fiber optic cable and associated equipment installed along public and private
24	property and rights-of-way (the "City Fiber Network"); and
25	
26	WHEREAS, the City Fiber Network provides sufficient capacity for both current,
27	proposed, and anticipated municipal fiber optic purposes and the City Fiber Network also provides
28 29	additional capacity that can be made available to others, including community anchor institutes; and
30	and
31	WHEREAS, the City and Arapahoe County (the "County") desire to participate
32	together in their capacities as governmental and political subdivisions in providing limited access
33	via fiber sharing to portions of the City and County Fiber Networks for the purpose of enhancing
34	communication systems used for public purposes; and
35	
36	WHEREAS, the City additionally desires to use the County as a Disaster Recovery
37	Site for Information Technology purposes; and
38	
39	WHEREAS, the terms and conditions related to the fiber sharing and the Disaster
40	Recovery Site are set forth in the attached intergovernmental agreement ("IGA"); and

42	WHEREAS, the City Council desires to approve the IGA, a copy of which is
43	attached hereto as Exhibit A.
