8 AN ORDINANCE OF THE CITY OF LITTLETON,  
9 COLORADO, AS THE GOVERNING BODY OF THE CITY  
10 OF LITTLETON, COLORADO SEWER UTILITY  
11 ENTERPRISE, ADOPTING THE 2021 BUDGET

13 WHEREAS, the city council established the City of Littleton, Colorado, Sewer  
14 Utility Enterprise (the “Enterprise”) by Ordinance Number 6, Series of 2004; and

15  
16 WHEREAS, the city council has determined it is in the best interest of all  
17 ratepayers to separate the cost of treatment versus the cost to operate, maintain and improve  
18 through capital construction the systems necessary to collect and transport the discharge for  
19 treatment; and

20  
21 WHEREAS, the city council, as the governing board of the Enterprise, has the  
22 authority under said ordinance to establish the budget for the Enterprise.

23  
24 NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF  
25 THE CITY OF LITTLETON, COLORADO, THAT:

27 **Section 1:** The budgeted expenditures for the City of Littleton, Colorado, Sewer  
28 Utility Enterprise for the period January 1, 2021 to December 31, 2021 shall be \$22,477,490.

29  
30 **Section 2:** Severability. If any part, section, subsection, sentence, clause or  
31 phrase of this ordinance is for any reason held to be invalid, such invalidity shall not affect the  
32 validity of the remaining sections of this ordinance. The City Council hereby declares that it would  
33 have passed this ordinance, including each part, section, subsection, sentence, clause or phrase  
34 hereof, irrespective of the fact that one or more parts, sections, subsections, sentences, clauses or  
35 phrases may be declared invalid.

36  
37 **Section 3:** Repealer. All ordinances or resolutions, or parts thereof, in conflict  
38 with this ordinance are hereby repealed, provided that this repealer shall not repeal the repealer  
39 clauses of such ordinance nor revive any ordinance thereby.

42 INTRODUCED AS A BILL at a regularly scheduled meeting of the City Council  
43 of the City of Littleton on the 6<sup>th</sup> day of October, 2020, passed on first reading by a vote of 7  
44 FOR and 0 AGAINST; and ordered published by posting at Littleton Center, Bemis Library, the

45 Municipal Courthouse and on the City of Littleton Website.

46 PUBLIC HEARING on the Ordinance to take place on the 20<sup>th</sup> day of October  
47 2020, in the Council Chamber<sup>1</sup>, Littleton Center, 2255 West Berry Avenue, Littleton, Colorado,  
48 at the hour of 6:30 p.m., or as soon thereafter as it may be heard.
