9	COUNCIL OF A CODE TEXT AMENDMENT TO TITLE 10, THE
10	UNIFIED LAND USE CODE, REGARDING THE 2024 LEGISLATIVE
11	UPDATES

14	WHEREAS, the City Council of the City of Littleton, Colorado passed Ordinance 24-2021
15	in October of 2021 which enacted Littleton City Code Title 10, the "Unified Land Use Code"
16	(ULUC); and
17	
18	WHEREAS, Section 10-9-3.2.A.4. of the ULUC authorizes the director of community
19	development to initiate a code text amendment; and
20	
21	WHREEAS, since October 2021, staff, property owners, business owners, and applicants
22	must comply with the ULUC with site-specific applications; and
23	
24	WHEREAS, the General Assembly of the State of Colorado passed House Bill 24-1007,
25	which prohibits limiting residential occupancy according to familial relation; and
26	
27	WHEREAS, the General Assembly of the State of Colorado passed House Bill 24-005,
28	which prohibits the new installation of artificial turf, invasive species and turf considered to be
29	"nonfunctional"; and
30	
31	WHEREAS, the General Assembly of the State of Colorado passed House Bill 24-1304,
32	which prohibits enforcing parking minimums on certain residential developments that are located
33	near a high-frequency transit stop; and
34	
35	WHEREAS, on May 12, 2025, the planning commission held a public hearing to consider
36	a recommendation to the Littleton City Council on the adoption of the code text amendment.
37	
38	NOW, THEREFORE, BE IT RESOLVED BY THE PLANNING
39	COMMISSION OF THE CITY OF LITTLETON, COLORADO, THAT:
40	
41	Section 1: Recommendation. The planning commission hereby recommends
42	adoption of the code text amendment of the Unified Land Use Code as referenced in Exhibit A,
43	attached hereto.
