

FIRST EXTENSION TO SHARED SERVICES AGREEMENT

This First Extension to Shared Services Agreement (this “First Extension”), effective as of January 1, 2026 (the “Extension Effective Date”), is an extension to the Shared Services Agreement, effective as of January 1, 2024, as amended (the “Agreement”) by and between CareATC, Inc. (the “Contractor”), Phil Long Dealerships, Inc. (“PL Client”), and the City of Littleton, Colorado (“City”). Together Contractor, PL Client and City may be referred to as the “Parties.”

RECITALS AND REPRESENTATIONS

WHEREAS, the City, PL Client, and OnSite Care, Inc. entered into the Agreement; and

WHEREAS, OnSite Care, Inc. sold substantially all its assets to the Contractor and has assigned its rights and obligations under the Agreement to the Contractor; and

WHEREAS, the Parties desire to extend the terms of the Agreement;

NOW, THEREFORE, in consideration of the benefits and obligations of the Agreement, the Parties mutually agree as follows:

1. Extension

The Agreement Initial Term is January 1, 2024 through December 31, 2025. Section 2.1 of the Agreement states that the Parties may extend or renew the Agreement for additional one year time periods through mutual written agreement. The Parties hereby mutually agree to extend the Agreement from January 1, 2026 through December 31, 2026.

2. Except as amended by this First Extension, all terms, provisions and conditions of the Agreement, as amended, remain unchanged and shall continue in full force and effect. The Agreement, as amended by this First Extension, constitutes the complete and entire understanding of Client and CareATC with respect to the subject matter hereof. In the event of a conflict between the terms and conditions of the Agreement and this First Extension, the terms and conditions of this First Extension shall govern with respect to the subject matter hereof.

3. This First Extension may be executed in counterparts, each of which will be deemed an original and all of which together will constitute one and the same document. Signature pages may be transmitted by facsimile, PDF, e-signature or other electronic means and shall be deemed original.

Exhibit A

Clinical Services

The following is a summary outline of the basic medical services provided by OnSite Care. Not all services are appropriate to all employer sites and will be determined by Client. The full scope of services adheres to and includes OnSite policies, procedures, practice protocols, laws and public health recommendations.

1. Primary care services
2. On site episodic care
3. In person and telemedicine (i.e., telephonic and virtual/video visits) between Providers and Participants during a Location's business hours).
4. Care and/or referral of chronic conditions
5. CLIA waived on-site lab testing
6. Promotion of generic equivalents to employees when appropriate
7. Phlebotomy
8. Health education and health promotion
9. Initial mental health screening and preliminary treatment for limited mental health conditions with required consultation
10. Provider PTO Coverage
11. Temporary staffing replacements when OnSite staff take leave pursuant to OnSite's policies.

Operational and Administrative Services OnSite will perform as ancillary and necessary to the Clinical Services:

1. Overall Clinic Management
2. Care Management of Participants in the Health Care Plans
3. Development of policies and procedures for treatment and staff management
4. Clinic design assistance and set up
5. OSHA/HIPPA compliance
6. Waste handling and disposal

OnSite does not provide the following services:

1. Travel immunizations
2. Pain management for chronic conditions
