32 33	WHEREAS, the city council finds that the proposed amendments are in the best interest of the city and promote the public health, safety and welfare of its inhabitants;

38 39 40 41 42	Section 1: Littleton City Code Section 10-3-2 is hereby amended to add 11.17 "Tattoo parlors and body arts studios" as a conditional use in the B-2, B-3 and CA zone districts, as shown:

2 3 **Section 2:** Littleton City Code Section 10-8-2 is amended by adding subsection (R) 4 to read as follows: 5 6 (R) Tattoo parlors and body arts studios: Tattoo parlors and body arts studios may be 7 permitted in the B-2, B-3 and CA districts subject to being no closer than 1,000 feet from 8 another tattoo parlor or body arts studio within the city. The planning board may apply 9 conditions to reduce the impact of the use on adjoining properties which may include, but 10 not limited to, hours of operation, parking, outdoor lighting and security measures. All signage must comply with section 4-3-2-5 of this code. 11 12 13 **Section 3:** Severability. If any part, section, subsection, sentence, clause or 14 phrase of this ordinance is for any reason held to be invalid, such invalidity shall not affect the validity of the remaining sections of this ordinance. The city council hereby declares that it would 15 16 have passed this ordinance, including each part, section, subsection, sentence, clause or phrase 17 hereof, irrespective of the fact that one or more parts, sections, subsections, sentences, clauses or 18 phrases may be declared invalid. 19 20 Repealer.
