7 A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF LITTLETON,
8 COLORADO, APPROVING A SUBAWARD WITH DENVER REGIONAL
9 COUNCIL OF GOVERNMENTS (DRCOG) FOR BUILDING
10 DECARBONIZATION POLICY WORK

12 WHEREAS pursuant to Section 1-15-62 of the Littleton Municipal Code, City
13 Council approval is a condition precedent to the approval of an amendment of an agreement in
14 which the total value of the agreement is over five-hundred thousand dollars and 00/100 cents
15 (\$500,000.00); and
16

17 WHEREAS the City will work with outside contractors to provide critical policy
18 recommendations, technical research, and data-driven strategies to ensure that Littleton’s efforts
19 to reduce energy consumption, improve building performance, and reduce greenhouse gas (GHG)
20 emissions are grounded in evidence and best practices; and

22 WHEREAS this subaward requires no matching funds from the City of Littleton;

25 WHEREAS the scope of work will assess energy performance, evaluate building
26 codes, and provide input on ordinances to drive meaningful change in; and

28 WHEREAS this work directly relates to adopted council initiatives in Horizon
29 2027 to implement the Environmental Stewardship Action Plan.

31 NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF
32 THE CITY OF LITTLETON, COLORADO, THAT:

34 Section 1. The Littleton City Council hereby approves the subaward agreement
35 with Denver Regional Council of Governments (DRCOG) to advance energy efficiency and
36 sustainability goals by utilizing funds for technical assistance to conduct critical evaluations,
37 develop tailored strategies, and draft policies, in substantially the same form as Exhibit “A,”
38 attached hereto.

40 Section 2 The Resolution shall take effect upon its approval by the Littleton City
41 Council.
