10 **AN ORDINANCE OF THE CITY OF LITTLETON,**
11 **COLORADO, ADOPTING THE 2017 FEE SCHEDULE**

13 **WHEREAS,** the city relies upon fees to provide services to customers and
14 citizens;

15
16 **WHEREAS,** fees associated with the services provided by the city require
17 adjustment from time to time to account for the increase in costs to provide such services; and

18
19 **WHEREAS,** the city council has determined that it is in the best interest of the
20 city to review city-wide fees on an annual basis;

22 **NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF**
23 **THE CITY OF LITTLETON, COLORADO, THAT:**

25 **Section 1:** The city hereby adopts the 2017 Schedule of Fees, attached hereto as
26 Exhibit A. The attached 2017 Schedule of Fees supersedes all previous fee schedules adopted by
27 city council and becomes effective January 1, 2017.

29 **Section 2:** Severability. If any part, section, subsection, sentence, clause or
30 phrase of this ordinance is for any reason held to be invalid, such invalidity shall not affect the
31 validity of the remaining sections of this ordinance. The City Council hereby declares that it
32 would have passed this ordinance, including each part, section, subsection, sentence, clause or
33 phrase hereof, irrespective of the fact that one or more parts, sections, subsections, sentences,
34 clauses or phrases may be declared invalid.

36 **Section 3:** Repealer. All ordinances or resolutions, or parts thereof, in
37 conflict with this ordinance are hereby repealed, provided that this repealer shall not repeal the
38 repealer clauses of such ordinance nor revive any ordinance thereby.

41 **INTRODUCED AS A BILL** at a regularly scheduled meeting of the City Council
42 of the City of Littleton on the 1st day of November, 2016, passed on first reading by a vote of 7
43 **FOR** and 0 **AGAINST**; and ordered published by posting at Littleton Center, Bemis Library, the
44 Municipal Courthouse and on the City of Littleton Website.

45 **PUBLIC HEARING** on the Ordinance to take place on the 15th day of November,

46 2016, in the Council Chambers, Littleton Center, 2255 West Berry Avenue, Littleton, Colorado,
47 at the hour of 6:30 p.m., or as soon thereafter as it may be heard.
