7 **INTRODUCED BY COUNCILMEMBERS:**

8  
9 **AN ORDINANCE OF THE CITY OF LITTLETON,**  
10 **COLORADO, REMOVING THE PERMITTING**  
11 **REQUIREMENT FOR PLACEMENT OF NEWSRACKS**  
12 **AND REMOVING RESTRICTIONS ON PURPOSES FOR**  
13 **WHICH NEWSRACKS MAY BE UTILIZED**  
14

15 **WHEREAS,** the Littleton City Code currently requires a permit to erect, place  
16 maintain or operate a newsrack on any public street or sidewalk;

17  
18 **WHEREAS,** the city council has determined that permits are no longer required  
19 to efficiently manage the placement of newsracks;

20  
21 **WHEREAS,** the city council also desires to remove the restrictions on the  
22 purposes for which newsracks may be utilized; and

23  
24 **WHEREAS,** city council has determined that it is in the best interest of the  
25 inhabitants of the City of Littleton to remove such restrictions and to remove the permitting  
26 requirement for newsracks;

27  
28 **NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF**  
29 **THE CITY OF LITTLETON, COLORADO, THAT:**

31 **Section 1:** Subsection B of section 5 and sections 2, 3, 4, 9 and 11 of chapter  
32 15 of title 3 are hereby deleted in their entirety.

33  
34 **Section 2:** Severability. If any part, section, subsection, sentence, clause or  
35 phrase of this ordinance is for any reason held to be invalid, such invalidity shall not affect the  
36 validity of the remaining sections of this ordinance. The City Council hereby declares that it  
37 would have passed this ordinance, including each part, section, subsection, sentence, clause or  
38 phrase hereof, irrespective of the fact that one or more parts, sections, subsections, sentences,  
39 clauses or phrases may be declared invalid.

41 **Section 3:** Repealer. All ordinances or resolutions, or parts thereof, in  
42 conflict with this ordinance are hereby repealed, provided that this repealer shall not repeal the  
43 repealer clauses of such ordinance nor revive any ordinance thereby.
