31 32 33	<b>Section 1:</b> Subsection B of section 5 and sections 2, 3, 4, 9 and 11 of chapter 15 of title 3 are hereby deleted in their entirety.
34 35 36 37 38 39	<b>Section 2:</b> Severability. If any part, section, subsection, sentence, clause or phrase of this ordinance is for any reason held to be invalid, such invalidity shall not affect the validity of the remaining sections of this ordinance. The City Council hereby declares that it would have passed this ordinance, including each part, section, subsection, sentence, clause or phrase hereof, irrespective of the fact that one or more parts, sections, subsections, sentences, clauses or phrases may be declared invalid.
41 42 43 44	<b>Section 3:</b> Repealer. All ordinances or resolutions, or parts thereof, in conflict with this ordinance are hereby repealed, provided that this repealer shall not repeal the repealer clauses of such ordinance nor revive any ordinance thereby.
