7 **INTRODUCED BY COUNCILMEMBERS:**

9 **AN ORDINANCE OF THE CITY OF LITTLETON,**  
10 **COLORADO, APPROVING A LEASE WITH PACIFIC**  
11 **OFFICE AUTOMATION TO PROVIDE COPIERS TO**  
12 **BEMIS PUBLIC LIBRARY**

13  
14 **WHEREAS,** Bemis Public Library provides coin-operated copiers for use by the  
15 public, and an additional copier for use by the staff, as part of its service delivery mission;

16  
17 **WHEREAS,** the library's current copier lease expires in September 2015;

18  
19 **WHEREAS,** the library staff, working with the Information Services and Finance  
20 departments, requested and received proposals, including a list of specific needs and  
21 requirements, for multi-year copier leases from four vendors;

22  
23 **WHEREAS,** the library staff conducted site visits and evaluated the information  
24 provided in the four bids; and

25  
26 **WHEREAS,** the City of Littleton and Pacific Office Automation desire to enter  
27 into an agreement to provide copiers to Bemis Public Library;

29 **NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF**  
30 **THE CITY OF LITTLETON, COLORADO, THAT:**

32 **Section 1:** The lease agreement between the City of Littleton and Pacific Office  
33 Automation to provide copiers to Bemis Public Library is hereby approved.

34  
35 **Section 2:** Severability. If any part, section, subsection, sentence, clause or  
36 phrase of this ordinance is for any reason held to be invalid, such invalidity shall not affect the  
37 validity of the remaining sections of this ordinance. The City Council hereby declares that it  
38 would have passed this ordinance, including each part, section, subsection, sentence, clause or  
39 phrase hereof, irrespective of the fact that one or more parts, sections, subsections, sentences,  
40 clauses or phrases may be declared invalid.

41  
42 **Section 3:** Repealer. All ordinances or resolutions, or parts thereof, in  
43 conflict with this ordinance are hereby repealed, provided that this repealer shall not repeal the  
44 repealer clauses of such ordinance nor revive any ordinance thereby.

47 **INTRODUCED AS A BILL** at a regularly scheduled meeting of the City Council  
48 of the City of Littleton on the 22<sup>nd</sup> day of September, 2015, passed on first reading by a vote of 7

1 FOR and 0 AGAINST; and ordered published by posting at Littleton Center, Bemis Library, the  
2 Municipal Courthouse and on the City of Littleton Website.

3 PUBLIC HEARING on the Ordinance to take place on the 6<sup>th</sup> day of October,  
4 2015, in the Council Chambers, Littleton Center, 2255 West Berry Avenue, Littleton, Colorado,  
5 at the hour of 6:30 p.m., or as soon thereafter as it may be heard.
