**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF LITTLETON,  
COLORADO, APPROVING CONSTRUCTION CONTRACT BETWEEN THE CITY OF  
LITTLETON AND EDGE CONTRACTING FOR THE SHADYCROFT ACRES  
SANITARY SEWER EXTENSION PROJECT – CITY PROJECT NO. 25-51**

12           **WHEREAS** pursuant to Section 1-15-62 of the Littleton Municipal Code, City  
13 Council approval is a condition precedent to the approval of an agreement in which the total value  
14 of the agreement is over five hundred thousand dollars and 00/100 cents (\$500,000.00); and

16           **WHEREAS** the city issued a Request For Proposals soliciting proposals for the  
17 Shadycroft Acres Sanitary Sewer Extension Project – City Project No. 25-51; and

19           **WHEREAS** the contractor, Edge Contracting submitted a response to perform the  
20 project and the city, after examination of the contractor’s submittal, has determined that the  
21 contractor has the requisite background, pricing, bond, and expertise to provide the requested  
22 work; and

24           **WHEREAS** city staff recommends acceptance of the contractor’s proposal for  
25 work in accordance with the issued Request For Proposals; and  
26

27           **WHEREAS**, the city and Edge Contracting desire to enter into an agreement, in  
28 which Edge Contracting will perform work in accordance with the terms and conditions outlined  
29 in the agreement, in substantially the same form attached hereto as Exhibit “A”.

31           **NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF**  
32 **THE CITY OF LITTLETON, COLORADO, THAT:**

34           **Section 1.** The Littleton City Council hereby approves the Construction Contract  
35 by and between the City of Littleton and Edge Contracting, for the Shadycroft Acres Sanitary  
36 Sewer Extension Project – City Project No. 25-51, in substantially the same form attached hereto  
37 as Exhibit “A,” and authorizes the Mayor to execute the same on behalf of the City of Littleton.

39           **Section 2.** The Resolution shall take effect upon its approval by the Littleton City  
40 Council.
