9 **AN ORDINANCE OF THE CITY OF LITTLETON,**
10 **COLORADO, APPROVING AN AMENDMENT TO THE**
11 **CUNNINGHAM FIRE PROTECTION DISTRICT'S**
12 **AGREEMENT FOR DISPATCH SERVICES**

14 **WHEREAS**, Littleton operates a combined fire communications and dispatch
15 center known as the Littleton Fire Rescue Communications Center (hereinafter referred to as the
16 "Center"); and

18 **WHEREAS**, Cunningham and Littleton entered into that certain Agreement dated
19 November 12, 2008 (the "Agreement");

21 **NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF**
22 **THE CITY OF LITTLETON, COLORADO, THAT:**

24 **Section 1:** The First Amendment to Agreement between the City of Littleton
25 and the Cunningham Fire Protection District for dispatch services is hereby approved.

27 **Section 2:** Severability. If any part, section, subsection, sentence, clause or
28 phrase of this ordinance is for any reason held to be invalid, such invalidity shall not affect the
29 validity of the remaining sections of this ordinance. The City Council hereby declares that it
30 would have passed this ordinance, including each part, section, subsection, sentence, clause or
31 phrase hereof, irrespective of the fact that one or more parts, sections, subsections, sentences,
32 clauses or phrases may be declared invalid.

34 **Section 3:** Repealer. All ordinances or resolutions, or parts thereof, in
35 conflict with this ordinance are hereby repealed, provided that this repealer shall not repeal the
36 repealer clauses of such ordinance nor revive any ordinance thereby.

41 ___ FOR and ___ AGAINST; and ordered published by posting at Littleton Center, Bemis
