33	to certify to the county commissioners of the County of Arapahoe, Colorado the mill levy for the		
34	Littleton Downtown Development Authority as hereinabove determined and fixed and the county		
35	assessor to extend the same to the tax rolls.

37	Section 3: Severability. If any part, section, subsection, sentence, clause or phrase of this ordinance is for any reason held to be invalid, such invalidity shall not affect the		
38 39	validity of the remaining sections of this ordinance. The City Council hereby declares that it would		
40	have passed this ordinance, including each part, section, subsection, sentence, clause or phrase		
41	hereof, irrespective of the fact that one or more parts, sections, subsections, sentences, clauses or		
42	phrases may be declared invalid.
