16	government bodies to furnish or receive governmental services, to make or pay for charges for
17	such services and to enter into cooperative or joint activities with other government bodies; and

19	WHEREAS, the City of Littleton plans to enter into an agreement with Mile High
20	Flood District, Arapahoe County, and South Suburban Parks and Recreation District to contribute
21	funds to the design and construction of improvements for South Platte River at Reynolds Landing,
22 23	with expected amendments to encumber future funds; and
24	WHEREAS, the city's 2025 share of the costs of the project, as set forth in the
25	Agreement, shall be a contribution of \$200,000 towards design and construction of the
26	improvements.

28	NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF
29	THE CITY OF LITTLETON, COLORADO, THAT:

31	Section 1. The Littleton City Council hereby approves the <i>Ninth Amendment to the</i>
32	Intergovernmental Agreement by and between the City of Littleton and Mile High Flood District,
33 34	regarding Design and Construction of Drainage and Flood Control Improvements for South Platte River at Reynolds Landing, Agreement No. 14-01.24I in substantially the same form as Exhibit
35	"A" and the mayor is hereby authorized to execute the intergovernmental agreement.
