

**CITY OF LITTLETON  
AMENDMENT NO. 1 TO SUBRECIPIENT GRANT AGREEMENT  
BETWEEN  
THE CITY OF LITTLETON AND BRIDGE HOUSE  
IN THE AMOUNT OF \$1,500,000  
IN SUPPORT OF THE TRI-CITIES READY TO WORK PROGRAM**

**THIS AMENDMENT TO THE SUBRECIPIENT GRANT AGREEMENT BETWEEN THE CITY OF LITTLETON AND BRIDGE HOUSE** (“Amendment”) is entered into by and between Bridge House, a 501C3 corporation whose business address is 5345 Arapahoe Avenue, Suite #5 Boulder, CO 80303 (“Grantee” or “Subrecipient”) and the **CITY OF LITTLETON, COLORADO** (“City”), a Home Rule municipality of the State of Colorado. The City and the Subrecipient may be individually referred to as “Party”, or collectively referred to as “Parties.”

**RECITALS AND REPRESENTATIONS**

**WHEREAS**, the City and Subrecipient entered into a subrecipient grant agreement in the amount of \$1,500,000 in support of the Tri-Cities Ready to Work Program (the “Agreement”) effective September 25, 2023; and

**WHEREAS**, the Parties desire to amend the Agreement.

**NOW, THEREFORE**, in consideration of the benefits and obligations of this Agreement, the Parties mutually agree as follows:

1. Extension of time:

The Parties wish to extend the termination date of the Agreement to align with the reporting period of the HUD FY23 Community Project Funding grant.

Section 5. of the Agreement, “Period of Performance”, shall be amended to read as follows: **“Period of Performance.** Subrecipient must fully finish the Projects(s) approved by the City by December 31, 2025.”

2. Reporting:

Section 8. of the Agreement, “Reporting Requirements” shall be amended to add a subsection 1.1, which reads as follows:

“1.1 *Monthly Report* - To satisfy HUD requirements for the FY23 Community Project Funding grant, the Subrecipient shall provide monthly financial and performance reports to the City beginning when funds are disbursed by the City to the Subrecipient.”

3. No other terms and conditions of the Agreement are modified except as provided in this Amendment.

4. The individuals executing this Amendment represent that they are expressly authorized to enter into this Amendment on behalf of the City and the Subrecipient and bind their respective entities.

THIS AMENDMENT is executed and made effective as provided above and as of the last dated signature below.
