7 A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF LITTLETON,  
8 COLORADO, APPROVING A PROFESSIONAL SERVICES AGREEMENT  
9 BETWEEN THE CITY OF LITTLETON AND MICHAEL BAKER  
10 INTERNATIONAL INC. FOR DESIGN SERVICES ON THE BROADWAY &  
11 LITTLETON BLVD. AND BROADWAY & MINERAL AVE.  
12 INTERSECTIONS

14 WHEREAS, pursuant to Section 1-15-62 of the Littleton Municipal Code, city  
15 council approval is a condition precedent to the approval of an agreement in which the total value  
16 of the agreement is over five-hundred thousand dollars and 00/100 cents (\$500,000.00); and

17  
18 WHEREAS, the city issued a Request for Qualifications for qualified firms to  
19 provide design services; and

20  
21 WHEREAS, Michael Baker International, Inc. (“Contractor”) submitted its  
22 qualifications to perform the requested scope of work, and the city, after examination of the  
23 Contractor’s submittal, has determined that the Contractor has the skill, ability, and expertise to  
24 perform the services requested in this Agreement; and

26 WHEREAS, the Parties desire to enter into this Agreement for the provision of  
27 design services by the Contractor.

29 NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF  
30 THE CITY OF LITTLETON, COLORADO, THAT:

32 Section 1. The Littleton City Council hereby approves the Professional Services  
33 Agreement by and between the City of Littleton and Michael Baker International, Inc. for design  
34 services on the Broadway & Littleton Blvd. and Broadway & Mineral Ave. Intersections, in  
35 substantially the same form attached hereto as Exhibit “A,” and authorizes the mayor to execute  
36 the same on behalf of the City of Littleton.

38 Section 2. The Resolution shall take effect upon its approval by the Littleton City  
39 Council.
