**A RESOLUTION OF THE PLANNING BOARD OF THE CITY OF LITTLETON, COLORADO, RECOMMENDING APPROVAL OF AN UPDATED NEIGHBORHOOD BOUNDARIES MAP AND UPDATED MAPS, GOALS, AND POLICIES FOR SEVEN OF THE CITY’S NEIGHBORHOODS AS AN AMENDMENT TO THE COMPREHENSIVE PLAN.**

**WHEREAS**, §2-9-1 of the city code defines the powers and duties of the planning board and states that the planning board shall recommend to the city council comprehensive plans to guide the future growth and development within the city, and states that such comprehensive plans shall be approved by city council; and

**WHEREAS**, the planning board held a public hearing on September 28, 2015, to consider recommending to city council a proposed amendment to the comprehensive plan, consisting of updates to the neighborhood boundaries map and to the maps, goals, and policies for the Centennial, Goddard, Heritage, Ketring Park, Progress Park, South, and Sterne Park neighborhoods; and

**WHEREAS**, following the public hearing on September 28, 2015, the planning board, after considering such evidence and testimony, voted to recommend approval of updated maps, goals, and policies for the Centennial, Goddard, Heritage, Ketring Park, Progress Park, South, and Sterne Park neighborhoods, as an amendment to the comprehensive plan, and to forward the proposed amendment to City Council for approval.

**NOW, THEREFORE, BE IT RESOLVED BY THE PLANNING BOARD OF THE CITY OF LITTLETON, COLORADO, THAT:**

The Planning Board does hereby recommend approval to the City Council of the updated maps, goals, and policies for the Centennial, Goddard, Heritage, Ketring Park, Progress Park, South, and Sterne Park neighborhoods as an amendment to the comprehensive plan.
