**A RESOLUTION OF THE PLANNING COMMISSION OF THE CITY OF  
LITTLETON, COLORADO, REGARDING AN AMENDMENT TO  
LITTLETON'S IMACT FEES, SECTION 11-7 AND SECTION 1 OF  
LITTLETON'S CITY CODE**

**WHEREAS**, the planning commission of the City of Littleton, Colorado, held a public hearing at its regular meeting of October 22, 2018 to consider a recommendation to city council to amend the city's capital facility impact fees for fire and transportation, and to move these fees from Subdivision (Title 11) to the Administrative (Title 1) section of Littleton's City Code, more specifically described in Exhibit A, which is attached hereto and made a part hereof by this reference;

**WHEREAS**, the planning commission considered evidence and testimony concerning the proposed amendment at said public hearing;

**WHEREAS**, the planning commission finds that the proposed amendment is consistent with the city's comprehensive plan; and

**WHEREAS**, the planning commission finds that the proposed amendment is in the best interest of the city and will promote the public health, safety, and welfare of its inhabitants by allowing for more efficient processing of subdivisions by the city;

**NOW, THEREFORE, BE IT RESOLVED BY THE PLANNING COMMISSION OF THE CITY OF LITTLETON, COLORADO, THAT:**

**Section 1.** The planning commission does hereby recommend that city council approve the proposed amendment, more specifically described in Exhibit A, regarding the city's capital facility impact fees for fire and transportation, and to move these fees from Subdivision (Title 11) to the Administrative (Title 1) section of Littleton's City Code.
