9 AN ORDINANCE OF THE CITY OF LITTLETON,
10 COLORADO, AMENDING ORDINANCE NO. 28 SERIES
11 OF 2013 KNOWN AS THE "ANNUAL APPROPRIATION
12 BILL" FOR ALL MUNICIPAL PURPOSES OF THE CITY
13 OF LITTLETON, COUNTIES OF ARAPAHOE,
14 JEFFERSON AND DOUGLAS, STATE OF COLORADO,
15 FOR THE FISCAL YEAR BEGINNING JANUARY 1, 2014
16 AND ENDING DECEMBER 31, 2014.

19 WHEREAS, Ordinance No. 28 Series of 2013 established the annual
20 appropriation for municipal purposes for the City of Littleton, Colorado;

22 WHEREAS, appropriations have theretofore been made for the expenditures of
23 monies pursuant to said budget; and

25 WHEREAS, the necessity of receiving and expending additional monies from the
26 various funds could not have been reasonably anticipated during the time of adoption of the
27 budget and appropriation of funds in accordance therewith;

29 NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF
30 THE CITY OF LITTLETON, COLORADO, THAT:

32 Section 1: Section 1: The budget of the City of Littleton for the fiscal year
33 beginning January 1, 2014, and ending December 31, 2014, is hereby amended by the addition to
34 the following fund:
