7 **A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF**  
8 **LITTLETON, COLORADO, AUTHORIZING AN**  
9 **INTERGOVERNMENTAL AGREEMENT BETWEEN THE CITY AND**  
10 **THE COLORADO DEPARTMENT OF TRANSPORTATION FOR**  
11 **REIMBURSEMENT OF COSTS ASSOCIATED WITH THE**  
12 **INSTALLATION OF IMPROVEMENTS AT THE INTERSECTIONS OF**  
13 **SOUTH PLATTE CANYON ROAD (SH75B) AND WEST BOWLES**  
14 **AVENUE AND SOUTH PLATTE CANYON ROAD (SH75B) AND WEST**  
15 **MINERAL AVENUE**

17 **WHEREAS**, the council may, by resolution, enter into contracts with other  
18 governmental bodies to furnish or receive government services, to make or pay charges for such  
19 services, or enter into cooperative or other joint activities with other governmental bodies; and

21 **WHEREAS**, the Colorado Department of Transportation and the City of Littleton  
22 desire to enter into an agreement associated with the improvements at the intersections of South  
23 Platte Canyon Road (SH75B) and West Bowles Avenue and South Platte Canyon Road (SH75B)  
24 and West Mineral Avenue; and

26 **WHEREAS**, the Colorado Department of Transportation intends to reimburse the  
27 city up to \$1,750,000 for the services performed by the city; and

29 **WHEREAS**, all work performed on this project will be in compliance with ADA  
30 requirements.

32 **NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF**  
33 **THE CITY OF LITTLETON, COLORADO, THAT:**

35 Authorization of the Intergovernmental Agreement between Colorado Department  
36 of Transportation for reimbursement of costs associated with the improvements at the  
37 intersections of South Platte Canyon Road (SH75B) and West Bowles Avenue and South Platte  
38 Canyon Road (SH75B) and West Mineral and the City of Littleton is approved.
