7 **INTRODUCED BY COUNCILMEMBERS:**

9 **AN ORDINANCE OF THE CITY OF LITTLETON,**  
10 **COLORADO, APPROVING AN AMENDMENT TO A 2012**  
11 **MASTER LEASE-PURCHASE AGREEMENT BETWEEN**  
12 **THE CITY AND JP MORGAN CHASE BANK, NA, FOR A**  
13 **FIRE PLATFORM TRUCK**

15 **WHEREAS**, the city fire department needs to replace a fire ladder truck; and

16  
17 **WHEREAS**, the amendment to a 2012 Master Lease-Purchase Agreement  
18 between the city and JP Morgan Chase Bank, NA, provides for the funding for a fire  
19 platform truck; and

21 **WHEREAS**, council deems the approval of the attached amendment to a 2012  
22 Master Lease-Purchase Agreement to be in the best interest of the city;

24 **NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF**  
25 **THE CITY OF LITTLETON, COLORADO, THAT:**

27 **Section 1:** The amendment to the 2012 Master Lease-Purchase Agreement  
28 between the city and JP Morgan Chase Bank, NA, is hereby approved.

29  
30 **Section 2:** Severability. If any part, section, subsection, sentence, clause or  
31 phrase of this ordinance is for any reason held to be invalid, such invalidity shall not affect the  
32 validity of the remaining sections of this ordinance. The City Council hereby declares that it  
33 would have passed this ordinance, including each part, section, subsection, sentence, clause or  
34 phrase hereof, irrespective of the fact that one or more parts, sections, subsections, sentences,  
35 clauses or phrases may be declared invalid.

37 **Section 3:** Repealer. All ordinances or resolutions, or parts thereof, in  
38 conflict with this ordinance are hereby repealed, provided that this repealer shall not repeal the  
39 repealer clauses of such ordinance nor revive any ordinance thereby.

41 **INTRODUCED AS A BILL** at a regularly scheduled meeting of the city council  
42 of the City of Littleton on the 15<sup>th</sup> day of November, 2016, passed on first reading by a vote of  
43 **FOR** and **AGAINST**; and ordered published by posting at Littleton Center, Bemis Library, the  
44 Municipal Courthouse and on the City of Littleton Website.

45 **PUBLIC HEARING** on the Ordinance to take place on the 6<sup>th</sup> day of December,

46 2016, in the Council Chambers, Littleton Center, 2255 West Berry Avenue, Littleton, Colorado,  
47 at the hour of 6:30 p.m., or as soon thereafter as it may be heard.
