Council Member Milliman moved and Council Member Rudnicki seconded to amend the ordinance to add Thursday 12:00 p.m. to 10:00p.m. at 80dB 10:00p.m. to noon at 55dB. The vote is 3-4 with Council Members Grove, Fey and Rudnicki and Mayor Pro-Tem Melin voting no. The motion to amend fails.

Council Member Milliman moved and Council Member Driscoll seconded to add Sunday's from noon to 6:00p.m. at 80dB. The vote is 4-3 with Council Members Grove, Fey, and Mayor Pro-Tem Melin voting no. The motion to amend carries.

Vote on the main motion is 4-3 with Council Members Grove, Fey and Mayor Pro Tem Melin voting no. The motion as amended carries.

The vote on the main motion is 6-1 with Council Member Milliman voting no. The motion carries.
