9 AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF
10 LITTLETON, COLORADO, AS THE GOVERNING BODY OF
11 THE CITY OF LITTLETON, COLORADO SEWER UTILITY
12 ENTERPRISE, AMENDING THE 2019 BUDGET

15 WHEREAS, the city council established the City of Littleton, Colorado, Sewer
16 Utility Enterprise (the “Enterprise”) by Ordinance No. 6, Series of 2004; and
17

18 WHEREAS, the city council, as the governing board of the Enterprise, has the
19 authority under said ordinance to establish the budget for the Enterprise; and
20

21 WHEREAS, Ordinance No. 41, Series of 2018 established the budgeted
22 expenditures for the City of Littleton, Colorado, Sewer Utility Enterprise; and

24 WHEREAS, the city council has determined it is in the best interest of all
25 ratepayers to separate the cost of treatment versus the cost to operate, maintain and improve
26 through capital construction the systems necessary to collect and transport the discharge for
27 treatment; and

29 WHEREAS, the necessity of receiving and expending additional monies from the
30 Enterprise could not have been reasonably anticipated during the time of adoption of this budget
31 and appropriation of funds in accordance therewith.

34 NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF
35 THE CITY OF LITTLETON, COLORADO, THAT:

37 Section 1: The budgeted expenditures for the City of Littleton, Colorado, Sewer
38 Utility Enterprise for the period January 1, 2019 to December 31, 2019 are hereby amended by
39 the following addition:

44 Section 2: The total budgeted expenditures for the City of Littleton, Colorado,
45 Sewer Utility Enterprise for the period January 1, 2019 to December 31, 2019 shall be amended
46 to \$20,446,488.

48 Section 3: Severability. If any part, section, subsection, sentence, clause or
49 phrase of this ordinance is for any reason held to be invalid, such invalidity shall not affect the

1 validity of the remaining sections of this ordinance. The City Council hereby declares that it
2 would have passed this ordinance, including each part, section, subsection, sentence, clause or
3 phrase hereof, irrespective of the fact that one or more parts, sections, subsections, sentences,
4 clauses or phrases may be declared invalid.

6 **Section 4:** Repealer. All ordinances or resolutions, or parts thereof, in
7 conflict with this ordinance are hereby repealed, provided that this repealer shall not repeal the
8 repealer clauses of such ordinance nor revive any ordinance thereby.

11 INTRODUCED AS A BILL at a regularly scheduled meeting of the City Council
12 of the City of Littleton on the 5th day of March, 2019, passed on first reading by a vote of 7 FOR
13 and 0 AGAINST; and ordered published by posting at Littleton Center, Bemis Library, the
14 Municipal Courthouse and on the City of Littleton Website.

15 PUBLIC HEARING on the Ordinance to take place on the 19th day of March,
16 2019, in the Council Chamber, Littleton Center, 2255 West Berry Avenue, Littleton, Colorado,
17 at the hour of 6:30 p.m., or as soon thereafter as it may be heard.

18 PASSED on second and final reading, following public hearing, by a vote of
19 FOR and _____ AGAINST on the 19th day of March, 2019 and ordered published by posting at
20 Littleton Center, Bemis Library, the Municipal Courthouse and on the City of Littleton Website.
