7 AN ORDINANCE OF THE CITY OF LITTLETON,  
8 COLORADO, AMENDING ORDINANCE NO. 23, SERIES  
9 OF 2024, APPROPRIATING FUNDS FOR THE 2025  
10 ANNUAL BUDGET FOR ALL MUNICIPAL PURPOSES OF  
11 THE CITY OF LITTLETON, COUNTIES OF ARAPAHOE,  
12 DOUGLAS, AND JEFFERSON, STATE OF COLORADO  
13 FOR THE FISCAL YEAR BEGINNING JANUARY 1, 2025,  
14 AND ENDING DECEMBER 31, 2025

16 WHEREAS, Ordinance No. 23, Series of 2024 established the annual  
17 appropriation for municipal purposes for the City of Littleton, Colorado: and  
18

19 WHEREAS, appropriations have theretofore been made for the expenditures of  
20 monies pursuant to said budget: and  
21

22 WHEREAS, the necessity of receiving and expending additional monies from the  
23 general funds could not have been reasonably anticipated during the time of the adoption of the  
24 budget and appropriation of funds in accordance therewith.

26 NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF  
27 THE CITY OF LITTLETON, COLORADO, THAT:  
28

29 Section 1: The budget of the City of Littleton for the fiscal year beginning January  
30 1, 2025, and ending December 31, 2025, is hereby amended by the following additions:

**Section 2:** The total budgeted expenditures for the funds listed above for City of Littleton, Colorado, for the period of January 1, 2025, to December 31, 2025 shall be amended to \$148,532,751.

**Section 3:** Severability. If any part, section, subsection, sentence, clause or phrase of this ordinance is for any reason held to be invalid, such invalidity shall not affect the validity of the remaining sections of this ordinance. The City Council hereby declares that it would have passed this ordinance, including each part, section, subsection, sentence, clause or phrase hereof, irrespective of the fact that one or more parts, sections, subsections, sentences, clauses or phrases may be declared invalid.

**Section 4:** Repealer. All ordinances or resolutions, or parts thereof, in conflict with this ordinance are hereby repealed, provided that this repealer shall not repeal the repealer clauses of such ordinance nor revive any ordinance thereby.

INTRODUCED AS A BILL at a regularly scheduled meeting of the City Council of the City of Littleton on the 6<sup>th</sup> day of May, 2025, passed on first reading by a vote of 7 FOR and 0 AGAINST; and ordered published by posting at Littleton Center, Bemis Library, the Municipal Courthouse and on the City of Littleton Website.

PUBLIC HEARING on the Ordinance to take place on the 20<sup>th</sup> day of May, 2025, in the Council Chamber, Littleton Center, 2255 West Berry Avenue, Littleton, Colorado, at the hour of 6:30 p.m., or as soon thereafter as it may be heard.

PASSED on second and final reading, following public hearing, by a vote of FOR and \_\_ AGAINST on the 20<sup>th</sup> day of May, 2025 and ordered published by posting at Littleton Center, Bemis Library, the Municipal Courthouse and on the City of Littleton Website.
