WHEREAS, the Council may, by resolution, enter into contracts with other
governmental bodies to furnish or receive governmental services, to make or pay for charges for
such services and to enter into cooperative or joint activities with other government bodies; and
WHEREAS, the City of Littleton has received a grant from 2024 Arapahoe County
Open Spaces grant program funds towards the High Line Canal Irrigated Tree Planting Pilot
Program; and
WHEREAS, the Arapahoe County Open Spaces department has drafted an
intergovernmental agreement regarding the grant that requires City Council approval; and
WHEREAS, the grant includes a total of \$353,000 towards the project with
Arapahoe County contributing \$233,000 and the High Line Canal Conservancy contributing a
match of \$120,000, as set forth in the Agreement.
NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF
THE CITY OF LITTLETON, COLORADO, THAT:
Section 1. The Intergovernmental Agreement between the City of Littleton and
Arapahoe County Open Spaces regarding the 2024 grant of Arapahoe County Open Space funds
for High Line Canal Stewardship Projects for the High Line Canal Irrigated Tree Planting Pilot
Program is approved, and the Mayor is hereby authorized to execute such intergovernmental
agreement.
