8 **A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF**
9 **LITTLETON, COLORADO, APPROVING FIRST AMENDMENT TO AN**
10 **INTERGOVERNMENTAL AGREEMENT BETWEEN ARAPAHOE**
11 **COUNTY AND LITTLETON PUBLIC WORKS DEPARTMENT FOR USE**
12 **OF THE ARAPAHOE COUNTY RADIO COMMUNICATIONS**
13 **NETWORK**

15 **WHEREAS**, the Public Works Department desires to utilize the Arapahoe County
16 Radio Communications Network (ACRCN) to maintain the ability to communicate by radio; and

17
18 **WHEREAS**, The Public Works Department is partner to an existing
19 Intergovernmental Agreement with the ACRCN that specifies costs per agency radio for annual
20 operation and maintenance of county-owned portion of the statewide Digital Trunked Radio
21 Systems; and

23 **WHEREAS**, the amended Intergovernmental Agreement will provide for the
24 continued use of the ACRCN and allow Public Works Department to maintain internal radio
25 functionality and interoperability with other city departments including Littleton Police
26 Department; and

28 **WHEREAS**, the Littleton Police Department entered into the first Amendment of
29 Intergovernmental Agreement by resolution for continued use of the ACRCN on January 21, 2020
30 which is a separate first Amendment from the first Amendment to Public Works Department using
31 the same agreement covering both departments; and

33 **NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF**
34 **THE CITY OF LITTLETON, COLORADO, THAT:**

36 The First Amendment to the Intergovernmental Agreement between Arapahoe
37 County and the Public Works Department for Shared Use of the Arapahoe County Radio
38 Communications Network is hereby approved.
