7 A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF LITTLETON,  
8 COLORADO, AUTHORIZING AN INTERGOVERNMENTAL  
9 AGREEMENT BETWEEN THE CITY OF LITTLETON AND THE BOARD  
10 OF COMMISSIONERS OF THE COUNTY OF ARAPAHOE, STATE OF  
11 COLORADO, REGARDING A FINANCIAL CONTRIBUTION FOR  
12 CONSTRUCTION OF THE MINERAL STATION WEST MULTIMODAL  
13 IMPROVEMENTS

15 WHEREAS the council may, be resolution, enter into contracts with other  
16 governmental bodies to furnish or receive government services, to make or pay charges for such  
17 services, or enter into cooperative or other joint activities with other governmental bodies; and  
18

19 WHEREAS the City of Littleton received funds from the Colorado Department of  
20 Transportation to design and implement infrastructure improvements near the Mineral Light Rail  
21 Station to enhance pedestrian, bicycle, and transit safety and accessibility elements along the Santa  
22 Fe Drive (US85), Southwest LRT line, and Mary Carter Greenway/South Platte River Trail  
23 corridors (the "Project"); and

25 WHEREAS Arapahoe County and the City of Littleton desire to enter into an  
26 agreement, in which Arapahoe County will financially contribute to the Project, and to further  
27 define the Parties role in relation to the Project, as further set forth in Exhibit "A;"

29 NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF  
30 THE CITY OF LITTLETON, COLORADO, THAT:

32 Section 1. The foregoing recitals are incorporated herein as if set forth in fully.

34 Section 2. The Intergovernmental Agreement between the City of Littleton and  
35 Arapahoe County Regarding a Financial Contribution to the Mineral Station West Multimodal  
36 Improvements Project is hereby approved, in substantially the same form as Exhibit "A" and the  
37 mayor is hereby authorized to execute the intergovernmental agreement.
