### 2018

The adoption of the Littleton Vision Report established a unifying vision and identified Littleton's core values, guiding principles, shared priorities, and concerns.

Denver Water has identified **several hundred feet of main line** in need of rehabilitation in Downtown Littleton due to the service age, high level of emergency repairs as well as significant leaking.



## 01 BACKGROUND

#### 2019

The Downtown Mobility & Streetscape
Improvements Plan (DMSIP) was a
resultant key recommendation from the
Envision Littleton 2040
Comprehensive Plan and the
Transportation Master Plan as
downtown parking constraints, multi-modal
connectivity, pedestrian-oriented safety
improvements, clear wayfinding, and
streetscape enhancements were identified as
high community priorities.

# \$ 01 BACKGROUND

#### 2021

Ballot Issue **3A** was approved by Littleton voters providing a funding source for future capital improvement projects.

Funding is proposed in 2023 for a downtown organization feasibility study.

#### 2022

City Council work plan identities Downtown focus as Goal 4.

City Council approves ordinance to establish the **Littleton Downtown Development Authority**. TABOR election to occur in November.

Downtown Mobility & Streetscape Improvements Plan **RFP** to be advertised in Fall 2022.

## 02 PLAN PURPOSE


The plan will allow investments in the focus area to be more **strategic** and guide **prioritization of all improvements** *while also* balancing the –

## 03 PLAN FOCUS AREA

The plan focus area will primarily concentrate on the **Downtown Core**; however, it will consider additional subareas – the **Downtown Gateway**, **the North Gateway, the South Gateway, and Riverside** – as well to foster connectivity and other improvements while preserving the dynamic heritage of Downtown Littleton.

## PROJECT MANAGEMENT TEAM (PMT)

Day-to-day project management (scope, schedule, budget, risk, change, stakeholder, etc.) in addition to management of overall project communications, meeting facilitation, deliverable development and review coordination, public outreach, etc.

Includes Public Works Senior Project Manager and Consultant Team

## TECHNICAL WORKING GROUP (TWG)

Confirm project management plan, communication protocol, public involvement plan, project strategies in addition to technical review of all project deliverables

Includes representatives from multiple City Departments including Public Works, Community Development, Economic Development, the City Manager's Office, and Communications

## STAKEHOLDER WORKING GROUP (SWG)

Serve as project ambassadors with other stakeholders, provide input and preliminary review of all project strategies and deliverables prior to public engagement

Includes key community stakeholders such as business / property owners and residents, Board representatives for the Planning Commission, Transportation and Mobility, and Historical Preservation

## CITY COUNCIL

Confirm plan vision, goals, and objectives as well as meet at key milestones to review strategies, public involvement tools, summary documents, policy recommendations and project deliverables; Final plan adoption

Includes all Littleton City Council members
