28	limited to the city's history museum, local library, Town Hall Arts Center, and a thirty-
29	acre botanical garden and event venue, not normally seen in a town of fewer than fifty
30	thousand people, that are worth supporting and maintaining; and

32	WHEREAS, Littleton was recently recognized as the Fourth Best City for Families
33	in Colorado by Livability.com and a Top 100 Best Place to Live in the United States; and
34 35	WHEREAS, access to arts and culture amenities are important components of
36	Envision Littleton and contribute to Littleton's high quality of life.
37	Envision Entiteton and contribute to Entitleton's high quanty of me.
38	NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF
