Neighborhood Meeting Notification <u>Rezoning of Broadridge Plaza Shopping Center</u>

The intent of this request is for the conversion of the existing space at Unit 15/Suite 199, (Southeast) corner of the shopping center, for the tenant improvement to accommodate a new "YouFit" business location. YouFit is a nationally recognized Health & Fitness club with (2) locations in the Denver Metro Area, and many location in other states. The scope of work for this project is predominately the interior tenant improvement of the old Safeway, and later JoAnn Fabrics, space to be repurposed for a Health and Fitness Club to be operated by the YouFit organization.
