7 **INTRODUCED BY COUNCILMEMBERS:**

9 **AN ORDINANCE OF THE CITY OF LITTLETON,**
10 **COLORADO, APPROVING A SOFTWARE**
11 **MAINTENANCE AND SUPPORT AGREEMENT WITH**
12 **CRW SYSTEMS, INC., FOR THE MAINTENANCE AND**
13 **SUPPORT SERVICES OF PERMIT AND CODE**
14 **ENFORCEMENT SOFTWARE**

16 **WHEREAS**, the city is currently using software developed and licensed by CRW
17 Systems, Inc. to conduct business relating to permitting, code enforcement, and land
18 management;
19

20 **WHEREAS**, the city desires to enter into a Software Maintenance and Support
21 Agreement with CRW Systems, Inc. for the maintenance and support services of this permit and
22 code enforcement software;

24 **WHEREAS** the city desires to lock-in the maintenance and support services costs
25 by entering into the agreement for a term of five years; and
26

27 **WHEREAS**, section 103 of the Littleton City Charter states that no contract for
28 service shall be made by the city for a period longer than two years, unless authorized by an
29 ordinance;

31 **NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF**
32 **THE CITY OF LITTLETON, COLORADO, THAT:**

34 **Section 1:** The Software Maintenance and Support Agreement between the city
35 and CRW Systems, Inc., is hereby approved.

37 **Section 2:** Severability. If any part, section, subsection, sentence, clause or
38 phrase of this ordinance is for any reason held to be invalid, such invalidity shall not affect the
39 validity of the remaining sections of this ordinance. The City Council hereby declares that it
40 would have passed this ordinance, including each part, section, subsection, sentence, clause or
41 phrase hereof, irrespective of the fact that one or more parts, sections, subsections, sentences,
42 clauses or phrases may be declared invalid.

44 **Section 3:** Repealer. All ordinances or resolutions, or parts thereof, in
45 conflict with this ordinance are hereby repealed, provided that this repealer shall not repeal the
46 repealer clauses of such ordinance nor revive any ordinance thereby.
