Investigation:

**ASSIGNMENT:**

On 11/05/14 at 2150 hours, I was dispatched to the Old Mill Brewery located at 5798 S Rapp St in reference to a verbal disturbance between two males and one female. While en route to the call LPD dispatch advised that the disturbance just turned physical and there was a gun involved.

**INVESTIGATION:**

Upon arrival I heard Sgt Dimitric advised that they had two males at gun point. I exited my patrol vehicle and ran back to assist officers in the rear parking lot on the east side. As I was approaching I noticed two males prone out on the ground. I helped Officer Carns place one of the males in handcuffs. Once the males were searched I heard one of them say "the guy with a gun is inside". I walked inside of the Old Mill Brewery to assist Cpl Carlson since there was possible someone with a gun inside.

As I walked inside I noticed two magazine stands knocked over and a baseball hat lying on the ground. I saw Cpl Carlson talking with a male party who was later identified by his CO DL as Peter Frangiskakis DOB [REDACTED]. Cpl Carlson and Peter were talking next to the entrance to the kitchen. Cpl Carlson pointed at a table and advised Peter that he needed to sit down. Peter stated "fuck you" and started to walk away. Cpl Carlson grabbed Peter's right arm and he curled in his arm and tried to pull away. Cpl Carlson grabbed Peter and pushed him into a table. I started running towards them and Cpl Carlson and I started yelling "Stop resisting". Peter grabbed Cpl Carlson and started pushing him towards the patio area. Cpl Carlson and Peter went to the ground near the end of the bar. Peter was on top of Cpl Carlson in the mounted position and was actively fighting Carlson.

I engaged from behind and knee struck Peter in the right common peroneal area. This strike on Peter had little effect; he was still fighting on top of Cpl Carlson. I delivered 3 to 4 hammer fist strikes to the mid back area on Peter. This allowed Cpl Carlson to create some room between him and Peter. Cpl Carlson called for help on the radio. Peter turned towards me and tried to engage me. I delivered a straight punch with my right hand to the left side of Peter's face. This knocked Peter back and Cpl Carlson was able to pull out his Taser. Cpl Carlson announced Taser three times and then shot Peter in the lower back on the left side near his belt line. Cpl Carlson conducted a drive stun to Peter's right hamstring area to improve the amount of distance between points of contact. Multiple officers arrived on scene and helped take Peter into custody at 2158 hours (handcuffs were double locked and checked for tightness).

Officers walked Peter out of the restaurant and to the patrol vehicles on S Rapp St. Peter continued yelling and cussing at the Littleton Police Department. The Taser probes were still in Peter's lower back which was bleeding onto his shirt. Peter was so amped up that I called for paramedics to check him on him. When paramedics arrived on scene they removed the probes from Peter and started to medically evaluate him.

While LFR was treating Peter on scene he made a statement that "If he had a gun he would kill all of us". Fire Fighter Zac Corley and Captain Paul Amend both completed written statements (case 2014-13111). LFR ended up transporting Peter to Littleton Hospital for further evaluation.

I walked to the rear parking lot and contacted Joshua White DOB [REDACTED] and Robert White DOB [REDACTED]. These were the two males that were placed into handcuffs at the beginning of the call. As I walked up I noticed that they were not in custody and they were standing there filling out written statements. I was advised by Officer Gordon that they were victims from the first altercation.

I interviewed Joshua and Robert about the original altercation. Both of their stories were identical.

Robert and Josh were eating dinner in the bar area of the restaurant when they heard the bar tender (Peter) yelling a female waitress near the kitchen. Robert heard noise which sounded like the Peter had hit something. Peter said something to the waitress to the effect of: you can be scared and shake like a little bitch if you want to but this is my place and I'm the king here. At this point Robert stood up and walked over to make sure that Peter was not hurting her. Peter looked at Robert and asked him if he was getting involved and Robert stated "no but I'm not going to let a man hit a women". Peter assured Robert that he was not going to hit her, just scare her. Peter apologized and offered to pay for Robert and Joshua's dinner.

Several minutes later Joshua and Robert heard the yelling escalating from the rear dining area of the restaurant. Robert called 911 to report the incident and while he was on the phone Peter walked up and asked if he had called the police. Peter told Joshua and Robert to leave the restaurant and Robert stated "ok". As Peter was escorting Robert and Joshua out he kept on saying "Get the fuck out" and at one point he stated "I will knock you fucking heads off". At this time Peter pushed Joshua from behind. Robert was still on the phone with 911 and told them that Peter had just pushed his son. Joshua and Peter started arguing about whether or not Peter pushed him.

Peter went around Robert and punched Joshua in the head. The fight went to the ground and Peter was on top of Joshua. Robert was able to wrestle Peter off of Joshua. Peter squared up to Robert and in self-defense Robert punched Peter in the face. Peter and Robert started wrestling around when Joshua came up from behind and put Peter in a triangle choke hold. Robert told Peter "I'm armed and drawing my weapon". Peter backed away and Robert and Joshua were able to walk away to their car. As Joshua and Robert were walking away Peter continued to taunt them calling Joshua a nigger.

Robert was not armed and only told Peter that in an attempt to stop the fight. Joshua was not injured from being punched other than being soar. Robert's right hand appeared to be broken from punching Peter. Robert refused medical treatment but advised that he would go to the emergency room afterwards. Robert was provided with a release form for his medical records and a SBI form. Robert and Joshua both completed written statements. Robert and Joshua both submitted to PBT tests and both blew a .000. Pictures were taken of his injuries.

Several minutes later Vasilios Frangiskakis "Bill" DOB [REDACTED] arrived on scene. Bill is the owner of the Old Mill Brewery and the father of Peter. When Bill arrived on scene he was very agitated at the police. As Bill started to calm down I asked him for a copy of the video surveillance tapes from inside the restaurant. Bill advised that the surveillance cameras were not working.

In Roberts statement he says that Peter was the bartender for the restaurant. After talking with Bill he advised that Peter was not working tonight, he was there drinking on his own time.

A female employee by the name of Cassandra Campbell DOB [REDACTED] walked up to officers and advised that she was working in the kitchen during the original verbal altercation. Cassandra filled a written statement. Cassandra heard Peter yelling at Becca about a receipt and told her she was a peasant and he didn't care if she was scared. Becca walked away and Peter followed her kept antagonizing her. Katie, Peter's girlfriend tried separating them and then Peter started yelling at her.

Peter was cleared from Littleton Hospital and transported to LPD headquarters and were he was placed in a holding cell number 1. During the investigation Peter refused to provide us with a PBT sample. Sgt Dimtric called Judge Feldman and requested that the bond be raised for Peter. Judge Feldman granted a \$10,000 bond for Peter. PC paperwork was completed and Peter was booked into Arapahoe County Jail for 2 counts of assault, disorderly conduct and obstructing a police officer.

During the altercation with Peter, I injured my left knee and was medically evaluated at Littleton Hospital. Dr Grandey advised that I likely have ligament or meniscus damage and further treatment is required.

**Narrative - Supplemental 1** SUPPLEMENTAL REPORT BY OFFICER LYNCH:

On 110514, at about 2200 hours, I responded to the Old Mill, 5798 S. Rapp St., to assist other officers.

At the request of Sgt. Dimitric, I unhandcuffed a white male wearing a Broncos sweatshirt in the parking lot to the east of the building. I provided that male and another male with statement forms and pens, but I did not collect the forms.

The male in the Broncos sweatshirt told me he thought he broke his hand "trying to pull him (the subject in custody on S. Rapp St.) off my son."

I also held down the lower legs of a male in custody on the sidewalk on the west side of S. Rapp St. because he appeared to be trying to kick the paramedics. When I was holding the male's legs down, I could hear him spitting, while the paramedics and officers were by his upper body and head, veballly attempting to calm him down. Officer Bishard asked me to go get a spit hood, which I did. I placed the spit hood over the male's head/face.

During the time I was on scene, I heard and saw the male yelling at the officers and paramedics, "You're fucking faggots! Take these handcuffs off me and I'll fuck you up!" and "If I had my guns, I'd kill all of you!" as well as other threats and profanities. He was also screaming at the paramedics, "If that's ketamine, it won't slow me down! I've done ketamine before and that won't do anything to me!" The male also yelled something about Al-Queda.

On 11/05/2014 at approximately 2153 hours, I responded to the Old Mill Brewery and Grill located at 5798 S Rapp St for a report of a disturbance.

Upon my arrival I could see that Officer Carns and Sergeant Dimitric had two males prone out and in hand cuffs in the parking lot on the east side of the bar. Upon assisting Officer Carns in patting down one of the males for weapons, I could hear Corporal Carlson yelling for help from inside the bar via radio. After Officer Gordon and I stayed with the two males who were in custody for a brief moment, Officer Carns took my position with the males while I went to my patrol vehicle to get statement forms. While at my patrol vehicle, I observed Corporal Farmer and other Littleton Police Department Police Officers escorting FRANGISKAKIS, PETER (DOB [REDACTED]) out of the north side doors of the bar while in handcuffs. While PETER was being escorted out of the bar I could hear him screaming profanities at the officers regarding a physical disturbance that had occurred inside of the bar. Once PETER was placed in the rear of Corporal Farmers patrol vehicle he continued to become more and more irate. During the altercation inside of the bar, PETER was tased; Littleton Fire Rescue had responded to check on PETER. While PETER was being checked by the medics, his level of verbal aggression continued to grow. During PETER's outburst he began yelling things like "you're all a bunch of pussies", "take me out of these handcuffs and your teeth will be all over this curb", and "If I had my guns, I would kill all of you". At one point while the medics were checking PETER, he began to push against the medics hands and tried to get off of the curb. Due to PETER's actions, Littleton Fire Rescue medics rolled PETER off of the curb to his right side and placed his chest of the ground. While I assisted in holding PETER on the ground for the paramedics, PETER turned his face towards my leg and foot and attempted to spit on me two times before yelling "fuck you". Because PETER began to spit, I requested that Officer Lynch place a spit hood on PETER to keep him from further spitting.

Once PETER was sedated by the paramedics, I followed the ambulance that PETER was on to Littleton Hospital. Once at the hospital, I took photos of PETER with Corporal Farmer's camera that was then turned over to Corporal Farmer. After PETER was medically cleared by the hospital, he was informed by staff that he was going to be released to the police. Once PETER saw me standing at his bed side, he began to growl while shadow boxing. Once PETER was released from the hospital, Officer Senior and I placed him back into handcuffs that were double locked and checked for tightness. PETER was transported to the Littleton Police Department and placed in holding cell #1 while Corporal Carlson complete arrest PC. While

SUPPLEMENTAL REPORT BY OFFICER KIEFFER:

On 11/05/2014 at 2150 hours I heard officers being dispatched to 5798 S Rapp Street (The Old Mill Brewery and Grill) on a disturbance.

As I pulled up on scene I heard officers advise that they had two male parties in custody in the parking lot. I exited my car and walked up to the officers to see if I could assist them. Just then I heard Corporal CARLSON yelling for help on the radio from inside the restaurant.

I quickly ran into the restaurant to assist Corporal CARLSON. As I got inside I observed Corporal CARLSON and Corporal FARMER struggling with a male party as Peter FRANGISKAKIS ([REDACTED]). P FRANGISKAKIS was attempting to pull away from them and was aggressively rolling in an attempt to get up. As he did this he was yelling obscenities. He said, "Get the fuck off of me." Corporal CARLSON and Corporal FARMER yelled for P FRANGISKAKIS to stop resisting. He didn't comply with these commands and instead continued to fight with officers.

As I approached the scuffle I observed a female party, identified as Kathleen CASHMAN ([REDACTED]), standing a few feet away. She was also yelling for the officers to get off of P FRANGISKAKIS. I told CASHMAN to step back so that she wasn't in the way. CASHMAN complied with my order and stepped away. At that point I turned around and began moving bar chairs out of the way. I then observed that P FRANGISKAKIS was in handcuffs and was under control. He did however continue to yell at officers.

We then escorted him out of the restaurant and had him sit on the curb to wait for LFR to respond. As we waited P FRANGISKAKIS continued to yell at officers.

As LFR arrived on scene I observed P FRANGISKAKIS' father, Vasilios FRANGISKAKIS ([REDACTED]) was standing across the street. He was yelling at officers and said, "How dare you beat my son up." I quickly walked across the street and told V FRANGISKAKIS to calm down and to not go across the street. At

first it appeared that V FRANGISKAKIS wasn't going to comply, however I was able to get him to calm down. I remained with him for the remainder of the call so that I could keep him calm and make sure he didn't obstruct our investigation.

On 10/19/2014 I handled a call involving P FRANGISKAKIS where he got into an argument with another employee, Dylan MEANS ([REDACTED]). During that argument P FRANGISKAKIS threatened MEANS by saying, "I'm going to beat your face in." P FRANGISKAKIS then began throwing things at the wall. MEANS told me that customers even got up and left the restaurant as P FRANGISKAKIS was throwing things. MEANS told me he didn't want to press charges. He also said he didn't want me to contact P FRANGISKAKIS in fear it might make things worse. See DR 2014-5189 for more details on that case.

On 110514 at about 2150 hours, I responded to the Old Mill, located at 5798 S. Rapp St. on a report of a disturbance possibly involving a firearm. While enroute, fellow officers aired on the radio that they had two subjects at gun point. As I arrived on scene, I observed two males prone out on the ground in the parking lot of the Old Mill.

I pulled into the parking lot and exited my vehicle. Upon exiting my vehicle, Cpl. Carlson got on the radio and called for "help." I knew that he was inside the restaurant, so I ran into the restaurant. When I entered the restaurant, I observed a male subject who was later identified as FRANGISKAKIS, Peter, DOB/[REDACTED] who was on the ground resisting Cpl. Carlson and Cpl. Farmer. Cpl. Carlson was yelling at FRANGISKAKIS to, "stop resisting," repeatedly. I also observed that Cpl. Carlson had his Taser on one of FRANGISKAKIS'S lower legs. I grabbed FRANGISKAKIS'S left arm and told fellow officers to roll him over. At this time FRANGISKAKIS'S right arm was tucked under his body and he was refusing to put his hand behind his back. I grabbed his right arm and moved it behind his back. While doing so, I could feel him attempting to pull his right arm away from me. During this, I told FRANGISKAKIS to, "Stop resisting." In this chain of events, Cpl. Farmer grabbed his right arm and took control. I then placed a handcuff on his left wrist and then his right wrist. FRANGISKAKIS was stood up by fellow officers and taken outside to a patrol car.

During this incident, I heard a female employee who was later identified as CASHMAN, Katie yelling that FRANGISKAKIS wasn't resisting and wasn't doing anything wrong. After FRANGISKAKIS was in custody I went and spoke with CASHMAN. She told me that one officer, identified as Cpl. Carlson, had come into the bar

and told FRANGISKAKIS to take a seat. CASHMAN told me that FRANGISKAKIS asked if he could go outside to have a cigarette to which Cpl. Carlson told him no and to have a seat. CASHMAN said that as FRANGISKAKIS was going to sit down, Cpl. Carlson came up and pushed FRANGISKAKIS against a table and grabbed his arm. CASHMAN continued to state that another officer came into the restaurant who was Cpl. Farmer and punched FRANGISKAKIS in the face and that it was unprovoked. At this point according to CASHMAN the officers pushed FRANGISKAKIS to the ground and Cpl. Farmer continued to punch him in the face. I asked if the restaurant had video cameras. She stated that they do, however they are not hooked up. I also asked CASHMAN if there were any other witnesses to the altercation between FRANGISKAKIS and Cpl. Carlson and Cpl. Farmer, which she told me she was the only one in the restaurant. I offered CASHMAN to fill out a written statement about what she had told me. CASHMAN was very hesitant about filling out a written statement, stating that she was very nervous and didn't know if she could. I gave her the statement and asked her to fill it out. I also asked CASHMAN what had happened prior to the police coming into the restaurant. She stated that she did not know because she was in the kitchen.

I went to check on fellow officers and came back later to check on CASHMAN, who had completed the statement. I asked her if the officers had told FRANGISKAKIS to sit down and he refused, to which she stated that he was told to sit down and he was going to sit down. During this time CASHMAN states that FRANGISKAKIS was completely cooperative and compliant. I left CASHMAN alone again and came back a few minutes later.

When I returned, I asked CASHMAN if she and FRANGISKAKIS were boyfriend and girlfriend. She stated that they were. I then asked if the two had argued prior to police arrival. She stated that they were in an argument about work and that FRANGISKAKIS was "amped up," and was yelling. Earlier CASHMAN had stated to me that she had heard FRANGISKAKIS yelling and came out to see why he was yelling. However now she was telling me that she and FRANGISKAKIS had an argument which is why he was yelling. She stated that shortly after this is when Cpl. Carlson came in and FRANGISKAKIS was very calm.

In another conversation I had with CASHMAN, in which Sgt. Dimitric was present for I asked CASHMAN if she had any alcohol to drink this evening. CASHMAN told me that she had nothing to drink. I asked her if she was telling me the truth, which she stated she was. I then told CASHMAN that I suspected she had been drinking because I could smell the alcohol on her breath. CASHMAN then said that she had forgotten that she had drank and that she had "tasters" of new beers that the restaurant had gotten in. She stated that in total she had about two drinks. It should be noted that CASHMAN had watery eyes, and an odor of an unknown alcoholic beverage emitting from her breath.

Later I was talking to FRANGISKAKIS, Vasilios "Bill" who is the father of FRANGISKAKIS, Peter and owner of the restaurant. He told me he wanted to press charges against the two males who were involved in the disturbance with FRANGISKAKIS, Peter for getting involved in an argument that FRANGISKAKIS, Peter was having with another female in the bar. FRANGISKAKIS, Vasilios stated that they should have minded their own business. I told him that a thorough investigation had been completed and that no charges were going to be pressed about the two males involved in the disturbance. He told me that they had been drinking. Having prior knowledge from a fellow officer that the two had not been drinking I told him that it was not true. He then yelled at CASHMAN and asked her if the two had been drinking. She hesitated and said that she had given both of

them shots. I asked her if she had the receipts, to which she replied that she didn't. I asked how they paid for the drinks and she said that the drinks were on the house. It should be noted that the two males did a PBT and blew .000 BAC's. It should be noted that I did speak with Cmdr. Eyman pertaining to what CASHMAN had told me.

**Narrative - Supplemental 5** SUPPLEMENTAL REPORT BY: SGT. N. DIMITRIC

On 0110514, at approximately 2149 hours, LPD communication aired out a verbal disturbance between two males and one female at 5897 S Rapp St (Old Mill). Dispatch then advised that verbal disturbance had turned physical and that there was a gun involved.

I responded from LPD headquarters running code 3 lights and sirens. I parked my patrol car at the corner of W Alamo Ave and S Rapp St. Upon exiting my vehicle, I heard fellow officers who were already scene giving loud verbal commands for someone to get down on the ground. I approached the parking lot of the Old Mill with my service weapon drawn and I observed two males prone out on the ground. I holstered my duty weapon and placed one of the males into custody. Since there was allegedly a gun involved both parties were thoroughly searched for weapons and no weapons were located.

Corporal Carlson who was also on scene entered the establishment to make sure that there was no other disturbances inside. While Corporal Carlson was inside the establishment I got on the radio and I asked Corporal Carlson which male had the gun. I was advised that the male with the alleged gun was an older male with gray hair. One of the males that was detained matched that description and was wearing a red Broncos sweatshirt.

Shortly after, I heard Corporal Carlson yell for help while inside the establishment. I immediately ran inside the bar and I observed Corporal Carlson and Corporal Farmer on the ground attempting place a male subject into custody. The male was actively resisting and was yelling profanities at officers "Get Fucking off me ". The male was refusing to place his arms behind his back and he had his arms tucked into his chest. The male had long hair so I grabbed a fistful of his hair and I started pulling on his hair in order to gain compliance while actively giving him verbal commands to stop resisting. While on the ground I observed that the male had been tased by the cartridge wiring that was located on the ground. The male continued resisting but officers managed to place the male into custody. The male was later identified as Peter Frangiskakis. During this incident, I observed a female, who was later identified as Katie Cashman yelling that Frangiskakis was not resisting and that he did nothing wrong. There were no other witnesses inside the establishment.

I assisted Corporal Farmer and Corporal Carlson in escorting the male outside the establishment and he was sat down on the street curb next to a patrol car. Corporal Farmer then advised me that he might have possibly hurt his knee while he was assisting Corporal Carlson in apprehending Frangiskakis.

The male continued to be belligerent and started calling Officers a bunch of "Pussies" and "Cowards". Since the Taser was deployed LFR was requested to our

location. Commander Eyman also arrived on scene and was briefed of the incident. Once LFR arrived on scene Frangiskakis continued to be verbally aggressive and uncooperative to the point that LFR administered Ketamine in order to calm him down.

While on scene, Frangiskakis made verbal threats to fire fighters and officers that if he had a gun that he would shoot us all. Once the Frangiskakis calmed down I met up with Sergeant Eich inside the establishment while he was talking to Cashman. I heard Sergeant Eich asking Cashman if she had consumed any alcoholic beverages this evening. Cashman stated that she had nothing to drink. Sergeant Eich then asked her if she was telling the truth and she replied that she was. Sergeant Eich informed Cashman that he could smell alcohol on her breath and Cashman then replied that she had some tasters of new beers that the restaurant had received. Cashman advised Sergeant Eich that she had a total of two beers.

I remained on scene while statements were gathered and all witnesses were interviewed. I also verified with LPD communications to see if anyone else inside the establishment had called 911 during the incident. I was informed that only one call was made which was from the original reporting party who was also the victim. No calls were received from Cashman or Frangiskakis. I had LPD communications burn a copy of the radio traffic as well as the initial 911 call on a CD which will be submitted into evidence.

I also spoke to Judge Feldman and I informed him of the incident. I requested that the bond be raised for this particular case and the request was granted by the Judge. Judge Feldman advised that the bond is to be set at \$ 10,000. I received a written confirmation via e-mail from the Judge in regards to the \$10,000 bond. A print out of the e-mail will be submitted to records. Nothing further.

On 11/5/2014, at 2150 hours, I responded to a disturbance at the Old Mill Brewery and Grill, 5798 S Rapp St, possibly involving a gun.

I immediately activated my overhead lights and sirens and advised Littleton PD Dispatch that I was en route code 3.

Upon arrival Officers Carns and Officer Senior had two unknown males at gun point in the back parking lot. I ran to the parking lot to assist Officer Carns and Officer Senior, but the two unknown males were already detained.

I entered the first set of front doors of the Old Mill and observed Cpl Carlson speaking to a unknown male wearing a bright green/yellow shirt, who was later identified as Peter Frangiskakis [REDACTED]. Cpl Carlson was just inside the

second set of front doors with the door open talking to Peter. The two sets of doors were approximately five feet apart.

Peter was yelling at Cpl Carlson, "That guy had a gun pointed to my head" Cpl Carlson asked Peter which party he was referring to. Peter stated "The white guy in the Broncos jacket, not the black guy."

I returned to the parking lot to advise Sgt. Dimitric that the male party in the Broncos jacket, who was later identified as Robert White [REDACTED] was the party with a gun. I began patting down Robert for officer safety, but no gun was discovered. While patting down Robert, Cpl Carlson advised all the units on scene that he needed "Help" inside the Old Mill Brewery and Grill.

Officer Bishard and I stayed with Robert and his son Joshua White, [REDACTED] in the parking lot while other Officers on scene responded to Cpl Carlson.

Robert was asked to fill out a voluntary statement regarding what occurred inside the Old Mill and Robert agreed.

Robert began filling out his statement, but stated that he did not know if he would be able to write because his hand was injured. Robert advised me that he believed his hand was broken from punching Peter in the head during the altercation. Robert stated that he punched Peter because Peter had hit Josh so Robert attempted to intervene and wrestle Peter away from Josh. Peter then turned and squared up on Robert as if he was going fight so Robert punched Peter as hard as he could in self defense.

Robert stated that he could not write a statement but would still complete one if someone would write it for him as he told them what to write.

I completed Robert's statement as he instructed me what to write. ( See Robert's statement for further information.)

Littleton Fire Rescue was on scene and examined Robert's hand, Robert declined to go to the hospital with LFR for further examination and stated he would take himself to the hospital later.

Officer Carns asked Robert to submit to a PBT to determine how much alcohol Robert had consumed tonight. The PBT results showed Robert's BrAC level was a .000. Robert advised me that he had consumed one shot of Crown Royal before his food arrived. Robert stated that Peter gave him the shot of Crown Royal before the altercation occurred.

Robert advised me that he had suffered a traumatic brain injury 7 years ago via a head on car accident, but that he did not need any further medical attention for the altercation.

I provided Cpl Farmer with Robert's statement.

SUPPLEMENTAL REPORT BY OFFICER CARNS 1402

On 11/05/2014 at approximately 2149 hours I was dispatched Old Mill Brewery & Grill located at 5798 S Rapp St, City of Littleton, County of Arapahoe, State of Colorado for a physical disturbance in progress with a firearm.

Littleton Police Department Dispatch stated that they had an open 911 line and heard someone make a comment about a gun. Dispatch advised that the two males were in the back parking lot.

I arrived first on scene and immediately observed two males in the back parking lot. With a potential firearm being involved in the physical disturbance I drew my weapon and ordered the two males to show me their hands and to get onto their stomachs. Both males complied and proceeded to the prone position on the ground. I took physical control of one male while Corporal Farmer handcuffed him. Sergeant Dimitric detained the second male. I checked both sets of the handcuffs for tightness and double locked them. I proceeded to search one male who did not have a firearm. Officer Bishard and I searched the male that I detained. Officer Gordon searched the second male who did not have a firearm on him.

While searching the male a call for help came out from Corporal Carlson inside the Old Mill Brewery & Grill. I was about to make entry into the Old Mill Brewery & Grill with the other officers but decided to go back to Officer Bishard and Officer Gordon who were with the two males for officer safety reasons.

The male I detained was identified by his Colorado Driver's License as Joshua Dean White ( [REDACTED] ). J. White stated that he and his Father were eating dinner at the Old Mill Brewery & Grill when there was a verbal disturbance between a male and female. His Father called 911 to report the incident and while passing the male who was involved in the physical disturbance the male started a verbal altercation with J. White asking if they were calling the police. When his Father said yes he was calling the police the male proceeded to "kick them out of the restaurant". While the male was forcing them out from the restaurant he began

pushing both of them and then struck J. White in the back with a closed fist. A physical altercation broke out between the three of them. I asked J. White if he needed medical attention, he refused. I asked J. White to write a statement being as detailed as possible of the incident.

His Father was identified by his Colorado Driver's License as Robert White ([REDACTED]). I took photographs of R. White's hand after he received injury during the physical altercation. The photographs have been submitted to Littleton Police Department Evidence.

Both J. White and R. White were administered a preliminary breath test, they both came back with BrAC of .000

Corporal Farmer collected the statement from White and I left the scene.

On 110514, at about 2150 hours, I, Corporal CARLSON responded to a possible disturbance at The Old Mill Brewery and Grill, 5798 S. Rapp Street, Littleton, Arapahoe, Colorado.

While en route, Littleton Police Dispatch advised that the disturbance was turning physical and there were possibly three (3) people fighting. Dispatch then aired that one (1) of the involved parties announced that he had a gun.

I immediately activated my overhead emergency equipment and responded from W. Main Street and S. Rio Grande emergent. I arrived on scene and blocked the southbound lane of S. Rapp Street. I then ran to the driveway, along the north side of the business, and observed several Littleton Police Officers placing two (2) males at gun point. As I approached I noticed the two (2) males, later identified as Robert WHITE ([REDACTED]) and Joshua WHITE ([REDACTED]), laying face down looking to the west. I heard an Officer asking, "Who has the gun?"

I heard one of the males say, "The guy with the gun is inside."

Fearing that there were additional patrons in the restaurant, who may be held at gunpoint, I approached the front door with my firearm at a low ready position.

In the foyer, I observed two (2) magazine racks that had been knocked over and magazines were scattered all over the floor. When I got closer, I noticed a black and gray baseball hat under the magazine rack.

I entered the restaurant and observed a female, later identified as Kathleen CASHMAN {DOB [REDACTED]}, standing in the area of the bar.

A male, later identified as Peter FRANGISKAKIS {DOB [REDACTED]}, approached from the left, wearing a bright green or fluorescent yellow shirt and shorts. FRANGISKAKIS was visibly "amped up" speaking rapidly, clinching his fists, and was unable or unwilling to focus and answer my questions. I asked FRANGISKAKIS what happened and he stated, "I just got my ass kicked." I noticed FRANGISKAKIS appeared to have a swollen lip and a small spot of blood on his face. FRANGISKAKIS stated that he had to kick out two (2) males (Robert WHITE and Joshua WHITE). FRANGISKAKIS said that when he was throwing them out the situation became physical and one of the males pulled a gun on him.

FRANGISKAKIS stated, "He had a gun pointed to my head." I asked FRANGISKAKIS several times which individual had the gun and he stated, "The guy in the Broncos sweatshirt." FRANGISKAKIS then said, "It was the older guy, not the black guy." I tried several times to get the information broadcasted to responding units, but FRANGISKAKIS was talking over me. Officer GORDON entered the foyer and began to relay the information, by running it back to the other officers.

FRANGISKAKIS was clearly agitated clinching his fists and pacing back and forth. In speaking with FRANGISKAKIS, I observed the heavy odor of an unknown alcoholic beverage emitting from his breath. FRANGISKAKIS had bloodshot watery eyes and an elevated tone of voice. I did not have an opportunity to ask FRANGISKAKIS if he had been drinking.

I began trying to conduct an interview with FRANGISKAKIS, but he continually talked over me. FRANGISKAKIS stated that he was going to go outside and smoke a cigarette. I told FRANGISKAKIS that he could not smoke right now, because I needed to speak with him and get some additional information. FRANGISKAKIS stated, "This is my fucking bar, you are not going to tell me what to do." FRANGISKAKIS said he was going out front and smoke. I explained to FRANGISKAKIS that the other males were still out front and he could not go out front. I told FRANGISKAKIS a minimum of five (5) times to sit down. FRANGISKAKIS again stated, "Fuck you, this is my fucking bar." FRANGISKAKIS stated something like, I'll just go to the patio. I then ordered FRANGISKAKIS to sit down and pointed at a "high-top" table, next to us. FRANGISKAKIS turned away from me and I ordered him to "Stop" and "Sit down" and he refused stating, "Fuck you this is my fucking bar."

FRANGISKAKIS then turned to walk away and I attempted to grab his right wrist to place him in the seat. When I grabbed FRANGISKAKIS's wrist his arm curled up towards his chest and he pulled away. I stepped forward pushing him into the table and began shouting at him to "stop resisting." FRANGISKAKIS immediately pulled away and spun in towards me. FRANGISKAKIS charged towards me, similar to a football tackle. FRANGISKAKIS arms were wrapped around my chest and back. FRANGISKAKIS then started driving me backwards. I was able to get my arms locked

around FRANGISKAKIS torso and began to lift up in a head-lock. I could see us moving quickly through the restaurant and towards the glass patio doors. Concerned that FRANGISKAKIS was going to push me completely through the glass, I decided to stop our movement by dropping down. I rapidly sat down, which brought FRANGISKAKIS towards the floor with me. Once on the floor FRANGISKAKIS was on top of me, but he still had one hand behind my back pinned.

I then observed Corporal FARMER engage in the fight and I was able to get out from under FRANGISKAKIS. I observed Corporal FARMER do several hammer fist strikes to the shoulder of FRANGISKAKIS. While FRANGISKAKIS was still actively fighting with Corporal FARMER and me, I was able to announce on the radio that we needed "HELP" inside the bar.

After calling for HELP, I believe I "shrimped" out and was able to deploy my Conducted Electrical Weapon (CEW) (TASER). I announced that I was going to deploy my CEW. I used a drive-stun deployment technique and observed the CEW's probes contact the lower left side of FRANGISKAKIS's back, just above the belt line. Attempting to improve the CEW's connection, I moved the CEW to FRANGISKAKIS's right hamstring area. FRANGISKAKIS shouted that he would stop, but was still actively resisting. Several other officers arrived and assisted in getting FRANGISKAKIS into custody. (CEW Cartridge #C4102ET6W)

Once FRANGISKAKIS was in custody, other officers attempted to walk him outside to a patrol vehicle, but FRANGISKAKIS was still actively resisting and trying to pull away. FRANGISKAKIS was still cursing and yelling that the Littleton Police Department was only trying to close down his fucking bar and extort money from him.

I noticed the area around the CEW's probes was beginning to bleed more than normal. We requested Littleton Fire Rescue to respond to treat FRANGISKAKIS. It appeared that when FRANGISKAKIS was resisting during handcuffing he rolled onto the probes and caused a more sever injury. FRANGISKAKIS was now in an excited uncontrollable state. When LFR arrived and was treating him, the decision was made to use Ketamine to calm FRANGISKAKIS.

I began to canvass the area for additional witnesses and noticed a male standing near his truck in the 5700 block of S. Rapp Street. The male, identified as Terry DAVIS (DOB [REDACTED]), by Colorado drivers license [REDACTED], stated that he did not see anything inside the restaurant, but that he did observe officers bringing FRANGISKAKIS out to a patrol car. DAVIS explained he heard FRANGISKAKIS still yelling and cursing at officers. DAVIS only provided a verbal statement, since he did not observed anything inside.

I then located a female in the back lot of the Old Mill. The female, identified as Cassandra CAMPBELL (DOB [REDACTED]), Colorado driver license [REDACTED], stated that she is an employee of the Old Mill. C. CAMPBELL stated that she did not see anything, but heard a lot of what happened. C. CAMPBELL stated, "I couldn't hear exactly what was said, but it was over a receipt." C. CAMPBELL described how he (PETER) was arguing with a waitress (only identified as Becca). C. CAMPBELL stated that FRANGISKAKIS was very angry and had followed Becca into the back still yelling at her. C. CAMPBELL then described how FRANGISKAKIS came

back to the dining area and began yelling at his girlfriend, the on-duty manager, Kathleen CASHMAN.

C. CAMPBELL stated that FRANGISKAKIS was intoxicated and often drinks on the job. I asked C. CAMPBELL if FRANGISKAKIS usually drinks at work and she stated, "Yes." C. CAMPBELL described how FRANGISKAKIS drinks almost nightly and is usually intoxicated at work.

C. CAMPBELL completed a written statement regarding what she heard.

I briefly heard Robert WHITE and Joshua WHITE explaining what happened. Robert WHITE explained that FRANGISKAKIS was making a scene and was yelling at CASHMAN. Robert stated that he was worried about CASHMAN's safety, so he approached and stood nearby. According to Robert, FRANGISKAKIS confronted him about getting involved in his business and then told them they had to leave. Robert explained that he and his son agreed to leave and began walking towards the exit, which FRANGISKAKIS was saying, "Get the fuck out." Robert then explained that FRANGISKAKIS shoved Joshua out the door, which started a physical fight between FRANGISKAKIS and Robert White.

I completed the probable cause paperwork for FRANGISKAKIS.

I arrived on scene and Ofc. CARNES and I began walking towards the Old Mill. Two (2) males were standing near a vehicle in the parking lot on the east side of the building. Ofc. CARNES ordered the two (2) males to lay on the ground, where they were handcuffed.

Cpl. CARLSON then stated that he needed help inside the Old Mill. I ran inside the restaurant and observed a male wearing a yellow shirt, lying on the ground and struggling with Cpl. CARLSON and Cpl. Farmer. Cpl. FARMER was yelling at the male to stop resisting, but he continued to yell and struggle as he was being handcuffed.

Once the male was handcuffed, I went back outside to the parking lot. I contacted Rebecca JOHNSON {DOB [REDACTED]} and Michael CAVALIER {DOB [REDACTED]}, who both work at the restaurant. JOHNSON stated that Peter is her boss and that he was upset about paperwork not being done right. Peter began yelling at her and another girl, when a customer told him not to talk to girls like that. Peter then began yelling at the male customer. JOHNSON then walked into the back. JOHNSON stated that Peter has a very bad temper and yells at people all the time. Johnson completed a written statement.

CAVALIER stated that he was working in the kitchen, when he heard Peter yelling in the main area of the restaurant. CAVALIER went to see what Peter was yelling about and observed him pushing two (2) males out the front door. CAVALIER went to intervene, when Peter yelled "he had a gun" and the two (2) males began walking away. Peter then began yelling at the two (2) males, "you're a bitch. You wouldn't have won if your dad didn't jump in". CAVALIER then walked Peter back into the restaurant. CAVALIER completed a written statement.
