25	amend the Littleton City Charter by the addition of a new Section 124, establishing a charter

38	Section 3: The City Council hereby authorizes and directs the officers of the City to
39	certify on or before September 4, 2015 the ballot question in substantially the form set forth in
40	Section 2 to the County Clerks in Arapahoe, Douglas and Jefferson Counties.

42	Section 4: The officers of the City are authorized and directed to take all other action
43	necessary or appropriate to effectuate the provisions of this ordinance.

1 Section 5: If a majority of the registered electors voting at the election on November 2 3, 2015 vote "yes" in response to the ballot question in Section 2, the Charter shall be amended 3 by the addition of the following new Section 124: 4 5 Sec. 124. Charter Review Committee. 6 7 The Council shall periodically appoint a charter review committee for the purpose 8 of performing a comprehensive review of the Charter, making recommendations 9 to the Council for amendments, deletions or other changes to the Charter and submitting such recommendations in writing to the Council. The committee shall 10 consist of at least fourteen (14) registered electors of the City, or such greater 11 12 number as the Council deems appropriate. 13 14 Section 6: Severability. If any part, section, subsection, sentence, clause or phrase of 15 this ordinance is for any reason held to be invalid, such invalidity shall not affect the validity of 16 the remaining sections of this ordinance. The City Council hereby declares that it would have 17 passed this ordinance, including each part, section, subsection, sentence, clause or phrase hereof, 18 irrespective of the fact that one or more parts, sections, subsections, sentences, clauses or phrases 19 may be declared invalid. 20 21 Section 7: Repealer.
