8 **RESOLUTION OF THE PLANNING BOARD OF THE CITY**  
9 **OF LITTLETON, COLORADO, RECOMMENDING**  
10 **APPROVAL OF AN ORDINANCE AMENDING TITLE 2 OF**  
11 **THE CITY CODE TO CHANGE THE NAME OF THE**  
12 **PLANNING BOARD TO PLANNING COMMISSION AND**  
13 **MAKING ASSOCIATED AMENDMENTS THROUGHOUT**  
14 **THE CITY CODE**

16 **WHEREAS**, the planning board of the City of Littleton, Colorado, held a public  
17 hearing at its regular meeting of August 8, 2016, to consider a proposed ordinance that will  
18 change the official name of the planning board to planning commission, more specifically  
19 described in Exhibit "A", which is attached hereto and made a part hereof by this reference;

21 **WHEREAS**, the planning board considered evidence and testimony concerning  
22 the proposed ordinance at said public hearing;

24 **WHEREAS**, the planning board finds that the proposed ordinance is consistent  
25 with the city's comprehensive plan; and

27 **WHEREAS**, the planning board finds that the proposed ordinance is in the best  
28 interest of the city and will promote the public health, safety, and welfare of its inhabitants;

30 **NOW, THEREFORE, BE IT RESOLVED BY THE PLANNING BOARD**  
31 **OF THE CITY OF LITTLETON, COLORADO, THAT:**

33 **Section 1:** The planning board does hereby recommend that city council  
34 approve the proposed amending title 2 of the city code to change the name of the planning board  
35 to planning commission and making associated amendments throughout the city code, more  
36 specifically described in the ordinance attached hereto as Exhibit "A".
