Council Member Cernanec moved and Council Member Clark seconded to approve on second reading the ordinance amending title 10 of the city code concerning residential uses in the B-2 Zone District and repealing the moratorium.

Council Member Clark moved and Mayor Beckman seconded to amend the main motion to amend the proposed ordinance to change line 45 of page 1 of the ordinance to read "nonresidential uses in the B-1 district provided the following conditions have been met" and to delete lines 11-13 on page 2 of the proposed ordinance and change 10-3-2.66 Land Use Table, removing residential from B-2. The vote on the amended motion is 3-4, with Mayor Pro Tem Brinkman and Council Members Cole, Cernanec, and Hopping voting no. The amended motion fails.

Council Member Cernanec moved and Council Member Clark seconded to amend the main motion to modify the distance requirement to 700 feet to notify property owners. Vote on the amended motion is 5-2 with Council Members Cole and Valdes voting no. The motion carries.

Council Member Clark moved to amend the ordinance to mail to property owners and occupants. The motion dies for lack of a second.
