7 **INTRODUCED BY COUNCILMEMBERS:**

9 **AN ORDINANCE OF THE CITY OF LITTLETON,**
10 **COLORADO, AS THE GOVERNING BODY OF THE CITY**
11 **OF LITTLETON EMERGENCY MEDICAL**
12 **TRANSPORTATION ENTERPRISE, ADOPTING THE 2017**
13 **BUDGET.**

15 **WHEREAS,** the city council established the City of Littleton Emergency
16 Medical Transportation Enterprise (the “Enterprise”) by Ordinance Number 15, Series of 2000;
17 and

18 **WHEREAS,** the city council, as the governing board of the Enterprise, has the
19 authority under said ordinance to establish the budget for the Enterprise;

21 **NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF**
22 **THE CITY OF LITTLETON, COLORADO, THAT:**

24 **Section 1:** The budgeted expenditures for the City of Littleton Emergency
25 Medical Transportation Enterprise for the period January 2, 2017 to December 31, 2017 shall be
26 \$3,977,110.

28 **Section 2:** Severability. If any part, section, subsection, sentence, clause or
29 phrase of this ordinance is for any reason held to be invalid, such invalidity shall not affect the
30 validity of the remaining sections of this ordinance. The City Council hereby declares that it
31 would have passed this ordinance, including each part, section, subsection, sentence, clause or
32 phrase hereof, irrespective of the fact that one or more parts, sections, subsections, sentences,
33 clauses or phrases may be declared invalid.

35 **Section 3:** Repealer. All ordinances or resolutions, or parts thereof, in
36 conflict with this ordinance are hereby repealed, provided that this repealer shall not repeal the
37 repealer clauses of such ordinance nor revive any ordinance thereby.
