9 **AN RESOLUTION OF THE CITY OF LITTLETON,**
10 **COLORADO, AUTHORIZING A MEMORANDUM OF**
11 **UNDERSTANDING BETWEEN THE CITY OF**
12 **LITTLETON AND THE LITTLETON/ENGLEWOOD BI-**
13 **CITY WASTEWATER TREATMENT PLANT**
14 **CLARIFYING THE OWNERSHIP AND MAINTENANCE**
15 **RESPONSIBILITIES OF THE LITTLETON 66”**
16 **INTERCEPTOR PIPELINE**

18 **WHEREAS,** the Council may, by resolution, recognize the signing of
19 Memorandum of Understanding (MOU) between the City and other government entities; and
20

21 **WHEREAS,** the City and the Littleton Englewood Wastewater Treatment Plant
22 (“L/E WWTP”) (collectively “the Parties”) have entered into an MOU clarifying the ownership
23 and maintenance responsibilities of a certain portion of the Littleton 66” pipeline ; and

25 **WHEREAS,** this MOU only clarifies ownership between the Parties and does not
26 constitute a transfer of ownership.

28 **NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF**
29 **THE CITY OF LITTLETON, COLORADO, THAT:**

31 **Section 1:** The Memorandum of Understanding between the City and the
32 Littleton Englewood Wastewater Treatment Plant is hereby recognized and affirmed.
33

34 **Section 2:** Severability. If any part, section, subsection, sentence, clause or
35 phrase of this ordinance is for any reason held to be invalid, such invalidity shall not affect the
36 validity of the remaining sections of this ordinance. The City Council hereby declares that it
37 would have passed this ordinance, including each part, section, subsection, sentence, clause or
38 phrase hereof, irrespective of the fact that one or more parts, sections, subsections, sentences,
39 clauses or phrases may be declared invalid.

41 **Section 3:** Repealer. All ordinances or resolutions, or parts thereof, in
42 conflict with this ordinance are hereby repealed, provided that this repealer shall not repeal the
43 repealer clauses of such ordinance nor revive any ordinance thereby.
