The city council hereby approves the Southbridge Planned Development, Fourth Amendment of Area K, to add assisted living, memory care, and accessory uses commonly associated with assisted living and memory care facilities to a portion of Area K of the Southbridge Planned Development for property located at 1501 West Mineral Avenue.

If any part, section, subsection, sentence, clause or phrase of this ordinance is for any reason held to be invalid, such invalidity shall not affect the validity of the remaining sections of this ordinance. The City Council hereby declares that it would have passed this ordinance, including each part, section, subsection, sentence, clause or phrase hereof, irrespective of the fact that one or more parts, sections, subsections, sentences clauses or phrases may be declared invalid.


