9 **AN ORDINANCE OF THE CITY OF LITTLETON, COLORADO,**
10 **AUTHORIZING THE EXECUTION OF AN INTERGOVERNMENTAL USER**
11 **AGREEMENT TO CONTRACT FOR DISPATCH SERVICES FOR FIRE AND**
12 **EMERGENCY MEDICAL SERVICES WITH THE SOUTH METRO FIRE AND**
13 **MEDICAL DISTRICT**

16 **WHEREAS,** the City of Littleton, Colorado has entered into an
17 intergovernmental agreement for Fire and Emergency Medical Services with the Littleton Fire
18 Protection District and the Highlands Ranch Metropolitan District; and
19

20 **WHEREAS,** the City of Littleton, Littleton Fire Protection District and
21 Highlands Ranch Metropolitan District have proposed to amend their intergovernmental
22 agreement to provide that a third party with the agreement of all three entities may provide
23 dispatch services under the Intergovernmental Agreement for fire and emergency medical
24 services;

26 **WHEREAS,** the City of Littleton has engaged in negotiations with the South
27 Metro Fire and Medical District on an intergovernmental user agreement for South Metro Fire
28 and Medical District to provide dispatch services to the parties in the intergovernmental
29 agreement.

31 **NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF**
32 **THE CITY OF LITTLETON, COLORADO, THAT:**
33

34 **Section 1:** That the City Council approves the Intergovernmental User
35 Agreement with the South Metro Fire and Medical District and authorizes the Mayor to execute
36 the Intergovernmental User Agreement on behalf of the City.
37

38 **Section 2:** Severability. If any part, section, subsection, sentence, clause or
39 phrase of this ordinance is for any reason held to be invalid, such invalidity shall not affect the
40 validity of the remaining sections of this ordinance. The City Council hereby declares that it
41 would have passed this ordinance, including each part, section, subsection, sentence, clause or
42 phrase hereof, irrespective of the fact that one or more parts, sections, subsections, sentences,
43 clauses or phrases may be declared invalid.

45 **Section 3:** Repealer. All ordinances or resolutions, or parts thereof, in
46 conflict with this ordinance are hereby repealed, provided that this repealer shall not repeal the
47 repealer clauses of such ordinance nor revive any ordinance thereby.

3 FOR and 1 AGAINST; and ordered published by posting at Littleton Center, Bemis Library, the
4 Municipal Courthouse and on the City of Littleton Website.
