21	the stream at Long Avenue, north of Mineral Avenue and south of West Jamison Way; and

25	improvements for Jackass Gulch, contributing funds for erosion mitigation and stream
26	stabilization; and

28	WHEREAS, the City's share of the costs of the project, as set forth in the
29	amendment to the agreement regarding design and construction of drainage and flood control
30	improvements for Jackass Gulch, shall be a contribution of 50% of the actual project costs, plus
31 32	indirect costs;
