Investigation: ASSIGNMENT:								
On December 31, 2016 at approximately 0031 hours, I was dispatched to the Platte River Bar and Grill, 5995 S. Santa Fe Dr. reference an motor vehicle accident.								
INVESTIGATION:								
Upon arrival, I contacted Scott Storey, DOB the property of a Blue Jeep bearing Colorado license plate 162ZCR. I asked Storey what had happened tonight and Storey said he was leaving there and pointed towards Arapahoe Community College, but his vehicle was in the southbound lanes of S. Santa Fe Dr. directly in front of the Platte River Bar and Grill. Storey then said he was turned around from the accident and believed that he was leaving the parking lot of the bar. Storey said that he was turning right and didn't even see the vehicle coming towards him. Storey than told me that he was making a left hand turn out of the parking lot and was hit by another driver.  While I was speaking with Storey I observed he had bloodshot eyes and that he was unsteady on his feet. I could								
smell an odor of an unknown alcoholic beverage coming from Storey's breath. I asked Storey if he had been drinking tonight and he said, "I had a couple of beers." Storey then immediately said, "I had 2 beers. No, I had a couple of beers." I explained to Storey that I was concerned about his ability to drive since he admitted to having a couple of beers, was involved in an accident and I could smell an unknown odor of an alcoholic beverage on his breath. Storey told me that there was no way I could smell alcohol on his breath. I asked Storey if he would be willing to do voluntary roadside maneuvers and he said, "No, I will not do roadsides."

I placed Storey in handcuffs, checked for tightness and double locked, and placed him in the rear of my patrol car. I explained Colorado Express Consent to Storey and asked if he would take a breath or a blood test. Storey said, "Breath test." I transported Storey to the Littleton Police Department where he completed his breath test which yielded a result of 0.144g/210L. A 20 minute deprivation period was done prior to Storey completing his breath test.

I placed Storey in a holding cell at the Littleton Police Department while I completed my probable cause paperwork.

Once my probable cause paperwork was completed I placed Storey in handcuffs again, checked for tightness and double locked, and placed him in the rear of my patrol car. I transported Storey to the Littleton Adventist Hospital for a medical clearance for jail.

Storey was medically cleared for jail by Dr. Morgan Skurky-Thomas.

Storey was placed in handcuffs again, checked for tightness and double locked, and placed in the rear of my patrol car. Storey was transported to the Arapahoe County Jail where was booked in on the charge of driving under the influence.

Storey was issued a citation #22451 for driving under the influence, failing to yield the right of way to oncoming traffic, and failed to present evidence of insurance. Storey was issued revocation #3273093.

Storey has no previous DUI convictions. Storey was positively identified by his Colorado driver's license.

Corporal Strong completed the accident investigation. Storey's vehicle was impounded at Conolly's Towing. Pictures were taken of the accident and later booked into LPD evidence.

Information/Supplemental Narrative: SUPPLEMENTAL REPORT BY CORPORAL STRONG:

I arrived on-the-scene of the accident and met with the driver of the #2 (victim) vehicle, Dustin Duncan (Dustin told me that he was traveling in the #1 (left hand through lane) south bound on S. Santa Fe Drive when suddenly a vehicle pulled out of the parking lot of the Platte River Bar and Grill and ran into the side of his vehicle. Dustin said that after he was struck, he hit his head and also hit the driver's door as his vehicle continued south bound on S. Santa Fe Drive swerving side-to-side. Dustin said he was surprised that his vehicle didn't spin around and he was able to keep it going mostly straight. I had Dustin complete a written statement and later collected it. James had a slight abrasion on the right side of his forehead but said he never lost consciousness and refused medical treatment. Dustin's wife came to the bar and drove him home.

Officer Guzman took photographs of the vehicles and the accident scene then assisted me in taking measurements. I completed a vehicle impound report (VIR) for the #1 vehicle, a 2013 Jeep Grand Cherokee, Colorado License: 162ZCR. A driver with Connolly's Towing responded and took both vehicles. Vehicle #2, 2001 Toyota 4Runner, Colorado License: 818XCJ was a private tow.

I completed an accident information (AI) report and turned in both the AI and the VIR to records. I dropped Officer Guzman's memory card from his camera into Property/Evidence.
