The female driver of the white PRIUS, JANICE FRAME () was cooperative with investigating officers while on scene. I was advised there was no indicia of alcohol or impairment noted in FRAME's behavior or person. FRAME did not suffer any injury from the accident.

I arrived at Littleton Adventist Hospital at 7700 S Broadway, City of Littleton, County of Arapahoe, State of Colorado to speak to CHACON and SALINAS. Upon my arrival I was advised by nursing staff they had detected the odor of an unknown alcoholic beverage emitting from CHACON's breath. I spoke to CHACON in emergency room 5. CHACON was conscious and understanding basic questions asked of him by medical staff and myself. I identified myself as a Police Officer with Littleton Police Department and explained to CHACON that due to the circumstances, and knowing he had consumed alcohol that I was now conducting an investigation for driving under the influence of alcohol. CHACON stated he understood, and stated he had been in Colorado Springs until approximately 1400 or 1500 hours and had consumed several, approximately 4-5 drinks prior to leaving Colorado Springs. CHACON stated he had consumed two alcoholic beverages while at the Platte River Bar and Grill prior to leaving. CHACON told medical staff he had consumed dinner at approximately 2000 hours while at the Platte River Bar and Grill.

Due to CHACON's medical status and one of his eyes being swollen shut I did not attempt to complete any voluntary roadside maneuvers at this time. I did detect the odor of an unknown alcoholic beverage emitting from CHACON's breath and spoke to him regarding his alcohol consumption on the night of 06.25.2017.

I spoke to SALINAS' doctor, AHAED STOWERS. STOWERS advised me that SALINAS had sustained serious bodily injury from the accident in the form of a complex fracture of her left ankle/foot which will require ortho intervention/stabilization and a concussion. STOWERS completed and signed a LPD serious bodily injury form which has been attached to this report.

I contacted SGT DIMITRIC and advised him of the SBI to SALINAS; SGT DIMITRIC informed on-call command and detectives. I spoke to CHACON and informed him of the change of investigation and stated due to the injuries SALINAS had sustained while a passenger of his motorcycle after he had consumed alcohol that it was necessary to perform a series of three (3) blood draws to determine his blood alcohol level. I asked CHACON if he understood, he stated, "Yes." I then asked CHACON if he consented to the three (3) blood draws, two of which would be completed while he was undergoing surgery, CHACON stated, "That's fine." CHACON signed all three (3) blood kit permission forms prior to being brought up to surgery. The first blood draw was conducted by RN D. ANGEL at 2225 hours on 06.25.2017. The second blood draw was conducted by RN J. MCCOY at 2325 hours. The third and final blood draw was completed at 0025 hours on 06.26.2017. All blood kits were booked into LPD evidence on 06.26.2017.

I was advised that CHACON was to be admitted to Littleton Adventist Hospital due to his injuries and the mandatory second surgery to follow. I provided hospital staff with a SBI form for CHACON and a medical information release form for both CHACON and SALINAS. I was unable to obtain signatures from either at this time due to altered mental status of both; CHACON was in surgery and SALINAS had suffered a concussion which caused her memory to be altered (she did not recall the events leading up to the accident). I will follow up with the hospital on 06.26.2017 for these forms.

I have completed probable cause paperwork for CHACON's arrest for Vehicular Assault and placed it in the to be served box in LPD records.

CHACON's criminal history and driver history does not indicate any previous DUI's on his record. LPD detectives were informed of the case.

I have nothing further at this time.

identified by her Colorado D. L. to be, Janice A. Frame, DOB: 05-31-55. Frame told me that she was traveling south bound on S, Santa Fe Dr from W. Church Ave in the number one through lane when a motorcycle appeared in front of her and she hit it. Frame told me that after she hit the motorcycle she slammed on her brakes but it was too late.

While talking to Frame, I did not observe any signs of intoxication nor any impairment. Frame was visibly shaken by the accident.

Cpl Quinton arrived on scene and conducted the accident investigation. I assisted Cpl Quintana and completed the Vehicle Inventory Report and both the motorcycle and the vehicle were impound and taken to Connelly's Towing, where Cpl Quintana would resume his examination of the Harley Davidson motorcycle and the Toyota sedan at a later date and time.

On 06/25/2017 at approximately 2030 hrs., I was contacted by LPD communications regarding an injury accident that occurred in front of 5995 S. Santa Fe Dr.

When I arrived on scene I observed a white in color Toyota Prius and a red in color Harley Davidson.

I was advised by officers on scene that the red Harley Davidson Failed to Yield Right of Way as it crossed lane #1 as it was attempting to make a left turn on to northbound S.
