SPEAR observed FOSTER stumble down the stairs into the west parking lot and get on his motorcycle. She stated that security contacted FOSTER and explained that FOSTER had not paid his bill. FOSTER handed security his credit card but security would not accept the card and got the server. SPEAR stated that WEBB, security, and a server approached FOSTER and told FOSTER he can't drive because he drank too much. SPEAR observed FOSTER get back on his motorcycle, which FOSTER had turned on, and WEBB placed his hands on the handle bars preventing FOSTER from leaving. FOSTER slowly pushed his front tire into WEBB'S calf. SPEAR observed FOSTER get off his bike and approach WEBB. She stated FOSTER "took off his vest to fight." FOSTER didn't touch WEBB but "got in his face" and made threats. WEBB was unable to calm FOSTER down. SPEAR stated that she "took a video of the event starting after [WEBB] got off his bike." She stated she would email the video to me. As of the time of this report, I have not received the video.

MONTAGUE stated the following in her written statement:

As MONTAGUE and her daughter, SPEAR, were walking the down the stairs to the west parking lot, she observed FOSTER stumbling down the stairs and weaving to his motorcycle. MONTAGUE observed security contact FOSTER about his unpaid bill. FOSTER handed security a card but security went back inside the bar to get the server. MONTAGUE observed FOSTER sitting on his motorcycle with the engine on. MONTAGUE told the server and security that she observed FOSTER to be very intoxicated. The server and security explained they were not going to let FOSTER drive. MONTAGUE observed WEBB contact FOSTER, and stated that FOSTER became "belligerent." FOSTER attempted to drive his bike into WEBB. FOSTER then got off his motorcycle and approached WEBB as he began swearing, insulting, and arguing with WEBB and security. MONTAGUE stated that WEBB handled the situation well. She also stated more employees came down the stairs and then police arrived. MONTAGUE also stated she observed a knife on FOSTER's belt and saw FOSTER reach for it once. Security also noticed and asked FOSTER to keep his hands raised.

MILLER stated the following in his written statement:

MILLER was sitting on the deck when he noticed a "man grinding on another man's back." The man didn't like the gesture and asked the "grinder" to stop. The "grinder" slapped the man in the back of his head, causing his hat to fall off. MILLER observed the "grinder" put the man in a choke hold and security told the "grinder" to leave the premises. MILLER identified the "grinder" as FOSTER. The other man was no longer on scene. I was unable to identify him.

Based on the large crowd of patrons and employees who had been involved in the incident at the Platte River Bar & Grill, I transported FOSTER to the Littleton Police Department to continue this investigation.

Upon arrival, I brought FOSTER into the booking area and advised him that he was under arrest for suspicion of DUI. I asked FOSTER if he would be willing to do voluntary roadside maneuvers and he said "no, I was not driving." I then advised FOSTER of Colorado's expressed consent law and gave him the option of blood or breath. FOSTER agreed to take a blood test.

I asked FOSTER what he wanted to do with his motorcycle. I gave him the option of leaving the bike in the parking lot, having it towed, or having someone come and get the motorcycle. FOSTER advised that he wanted to leave his motorcycle in the parking lot of Platte River Bar & Grill. I then transported FOSTER to Littleton Adventist Hospital.

Based on suicidal statements FOSTER made while at Littleton Adventist, he was admitted to the hospital for assessment by Nurse McCoy.

I reviewed FOSTER's criminal history and found that he has no prior alcohol related driving convictions.

I charged FOSTER with Disorderly Conduct (18-9-106), DUI (42-4-1301(1)(a)), and Careless Driving (42-4-1402(1)). This is citation # 22344. Due to FOSTER being admitted to Littleton Adventist, I could not fingerprint or photograph him.
