At your request, a background investigation was conducted on the above named establishment and the above named parties. The investigation included a check of Colorado Bureau of Investigation records. No derogatory information was discovered.

The records of the Littleton Police Department were also searched and the following incidents at this location were reported:

On 12/07/16 Officers responded to an intoxicated male who was later transported to jail. His bar tab showed 1 beer purchased inside the establishment. (LPD case # 17-6290)

On 12/31/16 Officers responded to a DUI accident. A patron left the bar and caused a traffic accident. His BAC was .144. (LPD Case # 16-6705)

On 5/28/17 Officers responded to a verbal disturbance in the parking lot. No charges were filed. (LPD Case # 17-2605)

On 6/25/17 Officers responded to a DUI accident. A motorcyclist leaving the bar pulled into on-coming traffic and he and his passenger were seriously injured. He was charged with DUI. (LPD Case # 17-3147)

On 7/9/17 Officers responded to a disturbance and eventually charged a motorcyclist with DUI. His BAC was .226 (LPD Case # 17-3383)

On 8/11/17 Officers responded to a disturbance and eventually made an arrest for disorderly conduct. The bar tab showed the purchase of two drinks. (LPD Case # 17-4003)

On 9/29/17 Officers responded to a theft from a vehicle in the parking lot. (LPD case # 17-4986)
