On October 7, 2016 at about 2343 hours, Officers were dispatched to The Castle Bar located at 6657 S Broadway on the report of a male swinging a sword. Dispatch aired that the male had gone into the parking lot but when I arrived on the scene, I didn't see anyone in the west portion of the parking lot. Dispatch then aired that the male had been pinned down by bar patrons and they were holding him for the police. I drove to the South portion of the parking lot and observed three males holding down another male.

I had the males continue to hold the male (later identified as David Quintana () while I got one hand cuff on his left wrist. One male got off and another brought David's right arm down and I hand cuffed that wrist. The other two males got off and I had David sit up. I observed a contusion to David's right forehead and abrasions on both of his elbows. David appeared to be intoxicated as his speech was strongly slurred and thick tongued. David's eyes were bloodshot and watery and I detected a strong odor of an alcoholic beverage on his breath.

I asked David his name, birth date, address and telephone number and he gave that information to me. I asked him if he had any identification and he said it was in his pocket. I checked all of his pockets and I only found a cellular telephone. I held on to that phone until I returned it to him at the hospital. I had it for safekeeping and did not try to access any information. I asked David what happened and he told me the following.

David said that he was outside in the parking lot and he found a sword and he grabbed it. He said he swung it at the crowd around him while telling them to "...get back." David told me he had arrived at 2000 hours with his girlfriend Lori PRINGLE () and they were having fun and drinking. After a while, some guy with a Mohawk came up to him and said, "Get the fuck out of here". David said, "You guys are punks" and left the bar. David walked outside into the parking lot and "found a sword" on the other side of a car. David said he grabbed the sword and began swinging it while saying, "Back Off." David then said, "I didn't mean to hit her." David said that some guys "Bum Rushed" him and tackled him and "...here we are."

I asked David where Lori was and he thought she might be in the parking lot to the west near a maroon van. I checked the parking lot for a maroon van or any females but there were none. I had dispatch do a query on Lori PRINGLE and they found that she owned a 1999 red Ford van. Lori's address is 6695 S Pearl Street Centennial CO 80122.

Because David was intoxicated, had a contusion on his forehead and because he had stated that he got knocked out, I requested that LFR Paramedics respond to check him. David was eventually transported to Littleton Hospital by LFR for medical treatment. I followed the Paramedic unit to the hospital and stayed with David. While at the hospital, David reiterated what he had told me to hospital staff loud enough that I could hear it standing in the hallway although he neglected to mention anything about a sword to them.

While in the hospital room, David called me in and told me that he would do anything to get out of going to jail this evening. He said that he would, "...give me a cookie (and) I'll give up a major drug dealer. He stated that he knows cartel members and he would be putting his life in serious danger but he would give me the information. I told him that we could talk to Officer Marquez when he arrived. David became irritated that I would not immediately accept his offer and then threatened to "...see to it that I never work anything but traffic..." if I didn't help him out.

David was cleared by the hospital for incarceration and they gave me a form to hand to the jail nurse regarding the clearance. I had David put his clothing back on and I hand cuffed him (double locked and checked for tightness). I walked David to my patrol car and seated him in the rear (prisoner area) and properly fastened the seat belt. NOTE: I

searched the prisoner area both before and after David was seated there and I found no contraband.

I transported David to the Littleton Police Department and we waited in my patrol car until Officer Marguez brought out the probable cause paperwork. I then transported David to the Arapahoe County Jail. While en route to the jail, David told me that the guy with the Mohawk hairstyle had told him to "Get the fuck out"...(of the bar) and David told him to step outside. David told me he said, "If you want to go (fight) let's step outside." David said that he is "prideful" and he never backs down from a threat.

David said that, once they got outside, there were several males and he felt threatened. He told Lori to leave so she would be safe and he looked around for something to defend himself like a rock or a stick and he found this sword on the ground. He said he didn't know where it came from. David said he started swinging it saying, "Back off, back off." He told me he had apologized for hitting the female and then next thing he knew, he had been tackled and was being assaulted by a bunch of guys. David said it was a this point that I showed up.

I did not ask David any questions while he was talking and didn't elicit any responses from him, he simply spoke about the incident. David spoke about many other things, religion, being in a gang when he was young, being arrested for cutting his cousin with a knife 10 years ago, to name a few. He talked nearly non-stop the entire trip to the jail.

Once inside the jail, I completed the booking report and face sheet for the probable cause paperwork. David was lodged in the jail on charges of Menacing. Assault in the Second Degree and Protection Order Violation. His bond was set at \$2,500.00

JStrong 200701 10/08/2016 **NARRATIVE** Category Investigation: ASSIGNMENT: On October 07, 2016 at approximately 2342 hours, I was dispatched to The Castle Bar and Grill, located at 6657 S Broadway, City of Littleton, County of Arapahoe, State of Colorado, in regards to a disturbance. Dispatch reported that the bartender was hit in the head with a sword and that the suspect was being restrained by customers. INVESTIGATION: Crpl. Strong arrived first on scene and placed the suspect into custody. When I arrived on scene, I contacted bartender Dawn Angelina Norby), who stated that she was struck in the head by a male who was swinging a sword at her and other patrons of the bar. Dawn explained that the male customer arrived at the establishment with a female at approximately 2130 hours. Dawn stated that the male was acting strange the entire time he was at the establishment, "Like he was on drugs." The male was later positively identified as David Anthony Quintana (). Dawn stated that David became upset when he was asked to leave the establishment multiple times by staff and other customers. David was asked to leave because he was "Rubbing everyone the wrong way" according to patrons of the bar. David exited the bar and returned momentarily with a samurai-like sword, with a blade approximately 28 inches long.

After Dawn was struck in the head, Shawn grabbed her and placed himself in front of her so she would not be struck again. Shawn's back was facing David, when David struck him in the back right shoulder with the bladed portion of the sword, causing a laceration approximately 10 inches long.

When Shawn was struck by the sword, David was restrained by multiple bar patrons until police arrived on scene. A bar patron secured the sword until police arrived. The sword was recovered and booked into LPD Evidence.

Dawn stated "The event was pretty serious, but I did not think I was going to die." Shawn stated that he was in fear for the safety of everyone involved in the incident because he knew the potential damage that the sword could cause. Both Dawn and Shawn completed statements, which were submitted with this report. Dawn and Shawn both were seen by LFR paramedics for their injuries but were not transported to Littleton Hospital. I photographed Dawn's and Shawn's injuries, which were submitted into LPD Evidence.

While conversing with David, I observed he had a strong odor of an unknown alcoholic beverage emitting from his breath and slurred thick speech. David voluntarily blew a 0.128 into a portable breath test. Due to David's intoxicated state, LFR Paramedics arrived on scene and transported him to Littleton Hospital for a medical clearance.

I requested LPD Dispatch to perform an NCIC/CCIC clearance for David. LPD Dispatch advised that David had an active mandatory protection order through Denver County which restrains him from consuming or possessing alcoholic beverages or controlled substances (issued 09/04/2006, expires 07/19/2018, CCIC #109393292).

I requested a bar receipt for the alcoholic beverages purchased by David. The receipt showed that David purchased a total of nine alcoholic beverages and closed his tab at approximately 2355 hours. Dawn stated that David split the alcoholic beverages between him and his girlfriend who was no longer on scene upon police arrival.

David was medically cleared for jail by hospital staff and transported to ACSO Jail by Crpl Strong.

David was charged with menacing, assault in the 2nd degree, and crime of violation of a protection order.

Supplemental Report by Officer A.Larson 201509:

When I arrived on scene to The Castle, located at 6657 S Broadway, I observed Corporal Strong with a male subject, later identified as David, in custody on the ground on the south side of the building.

I went into the restaurant and spoke to a bartender, Don who was hit in the right eyebrow with a sword. Don advised that David was wielding in the sword in the air and aggressively yelling at patrons in the restaurant. Don handed me the sword that David was disarmed of. The sword was approximately three feet in length. I took the sword from Don and placed it in the passenger side of my patrol car. I later took the sword from my patrol car and placed it in the passenger side of Officer Marquez's patrol car.

I stood next to David while LFR was asking him medical questions. I heard the subject tell LFR that he had consumed seven beers throughout the evening. David was making erratic movements and rapidly repeating himself when speaking to LFR. Nothing further.

That this Affiant is a law enforcement officer with the Littleton Police Department and that the following information was obtained by me personally and from official records of the aforementioned department.

SUMMARY:

David QUINTANA threatened to kill patrons of a bar. In the parking lot of the bar, QUINTANA swung a sword, striking the bartender in the head and a patron in the back. QUINTANA consumed alcohol in violation of a protection order.

On October 7, 2016, at 11:42 PM, Littleton Police Officers responded to The Castle Bar and Grill, 6657 South Broadway, City of Littleton, County of Arapahoe, State of Colorado on a report of the bartender being hit in the head with a sword.

Littleton Police Corporal John STRONG arrived and reported the following:

Corporal STRONG noticed QUINTANA appeared to be intoxicated as his speech was strongly slurred and thick tongued. His eyes were bloodshot and watery and Corporal STRONG detected a strong odor of an alcoholic beverage on his breath.

Corporal STRONG asked QUINTANA for his name, birth date, address, and telephone number, to which QUINTANA provided the information. QUINTANA claimed to have identification in his pocket, but Corporal STRONG was unable to find any identification.

Corporal STRONG asked QUINTANA what happened and was told the following:

QUINTANA arrived at The Castle Bar and Grill at 8:00 PM; they were having fun and were drinking. After a while, some guy with a mohawk came up to him and said, "Get the fuck out of here." QUINTANA replied, "You guys are punks," and left the bar.

QUINTANA was outside in the parking lot and he found a sword and he grabbed it. He swung it at the crowd around him while telling them to, "get back," and, "back off." "I didn't mean to hit her." Some guys, "bum rushed," him and tackled him and, "...here we are."

QUINTANA stated that he had got knocked out.

Corporal STRONG had Littleton Fire Rescue come to the scene to check on QUINTANA. Littleton Fire Rescue transported QUINTANA to Littleton Hospital while Corporal STRONG followed them to the hospital.

At Littleton Hospital, QUINTANA called Corporal STRONG into the room and said he would do anything to get out of going to jail this evening. QUINTANA stated he would, "...give me [Corporal STRONG] a cookie (and) I'll give up a major drug dealer." QUINTANA said he knows cartel members and would be putting his life in serious danger but would give the information.

Corporal STRONG told QUINTANA to talk with Officer MARQUEZ, the primary officer, when he arrived. QUINTANA became irritated Corporal STRONG would not immediately accept the offer and then threatened to, "...see to it that I never work anything but traffic..." if Corporal STRONG did not help him out.

QUINTANA was cleared for jail by staff at Littleton Hospital.

Corporal STRONG transported QUINTANA to jail. While en route to the jail, QUINTANA made statements to Corporal STRONG, who did not respond or question him in any way. QUINTANA stated the following:

The guy with the mohawk hairstyle told him to, "get the fuck out," and QUINTANA told him to step outside. QUINTANA said, "if you want to go (fight) let's step outside." QUINTANA is "prideful," and never backs down from a threat.

Once they got outside, there were several males and QUINTANA felt threatened. QUINTANA told PRINGLE to leave so she would be safe. QUINTANA looked around for something with which to defend himself, such as a rock or stick. He found a sword on the ground, although he did not know where it came from. QUINTANA swung the sword, saying, "Back off, back off."

QUINTANA had apologized for hitting the female and the next thing he knew, he was tackled and assaulted by a bunch of guys. This is the point where Corporal STRONG showed up.

QUINTANA was booked into ACSO for the following:

QUINTANA'S bond was set at \$2,500.

Littleton Police Officer MARQUEZ reported the following:

He arrived at The Castle Bar and Grill and contacted Bartender Dawn NORBY (DOB 11-28-1982) who stated the following:

QUINTANA came to the bar with PRINGLE around 9:30 PM. QUINTANA acted strange the entire time he was at the bar, "like he was on drugs."

QUINTANA was, "rubbing everyone the wrong way," and was asked multiple times to leave by both staff and customers. QUINTANA left the bar and returned momentarily with a samurai-like sword, with a blade 28 inches long. [Your Affiant later measured the blade using a measuring tape and found it to be 28 inches]. [There is no indication QUINTANA came back into the bar, but was only in the parking lot].

Customers told NORBY that QUINTANA had a sword and was in the south parking lot. Customers and staff went to the parking lot where QUINTANA yelled at people, "you guys wanna go? I'll kill all of you."

QUINTANA swung the sword towards the crowd.

NORBY stepped between QUINTANA and a customer, Shawn KELLEY (), and tried to calm him down. QUINTANA swung the sword at KELLEY but missed, striking NORBY in the head with the bladed portion of the sword, causing a two inch laceration above her right eye.

KELLEY grabbed NORBY and stepped in front of her so she would not be hit again. KELLEY'S back was to QUINTANA. QUINTANA struck KELLEY in the back right shoulder with the bladed portion of the sword, causing a laceration 10 inches long.

Multiple customers restrained QUINTANA until police arrived. One customer took and held the sword.

"The event was pretty serious, but I did not think I was going to die." She was in fear for the safety of everyone involved because she knew the potential damage the sword could cause.

Littleton Fire Rescue checked NORBY and KELLEY but did not transport them to the hospital. Officer MARQUEZ photographed the injuries to NORBY and KELLEY.

Officer MARQUEZ detected a strong odor of an unknown alcoholic beverage on QUINTANA'S breath. QUINTANA voluntarily blew into a portable breath test resulting in a .128 BrAC. Littleton Fire Rescue transported QUINTANA to Littleton Hospital.

Littleton Police Officer Anne LARSON reported the following:

She saw Corporal STRONG with QUINTANA; QUINTANA was in custody on the ground on the south side of the building.

She spoke with NORBY who said QUINTANA was wielding the sword in the air and aggressively yelled at patrons in the restaurant. NORBY gave the sword to Officer LARSON.

Officer LARSON stored the sword in her patrol car until she moved it to Officer MARQUEZ'S patrol car.

She stood by QUINTANA while Littleton Fire Rescue was checking him. QUINTANA told LFR personnel he had consumed seven beers throughout the evening. QUINTANA made erratic movements and rapidly repeated himself.

Dawn NORBY provided a written statement as follows:

9pm he arrived, seemed like he was on drugs - had issues with him wanting to fight some people - closed out tab at 11:45 he left everyone went outside - he was gone, then came back around the corner with a samari sward [sic] - started swinging - saying he was gonna kill people & seatle [sic] a fight - I don't know he was crazy - hit me in the head about y right eye with sword - was taken down by Chad - & held in place till you arrived with the sword behind the bar not in fear of my life.

Shawn KELLEY provided a written statement as follows:

I put my hand on the guys sholder [sic] he got offended and left he came back with a sword and hit dawn [NORBY] with the sword then hit me in the back and then was tackeled [sic] from behind and we held him down until the police
