Information/Supplemental Narrative: INFORMATION REPORT:  On 09/05/2017 at approximately 2118 hours, I was dispatched to The Castle (6657 S. Broadway) on a report of a male refusing to leave or pay his tab. The male was described as a white male with white hair, a green shirt, and jeans.  I arrived on scene with Officer Larson and had the male pointed out to me by one of the employees. The male was positively identified as MORGAN, Mark ( ) via CO DL ( ) Upon contact MORGAN's eyes were blood shot and watery, his speech was slowed and slurred, and there was the odor of an unknown alcoholic beverage emitting from his breath.  I asked MORGAN if he could exit the bar and talk with me. MORGAN stated, "No I don't see why I should." I told MORGAN that he needed to leave and pay his bill. MORGAN stated, "Nope."  Officer Larson and I grabbed MORGAN by his arms and escorted him out of the bar. MORGAN was not able to walk on his own and continuously lost his balance and was attempting to pull away from us. We placed MORGAN into custody (hand cuffs double locked and checked for tightness) at approximately 2127 hours, and placed him into the back of my patrol vehicle.  I was advised by the waiter that MORGAN had not paid his bill. I asked MORGAN if he would pay his bill and he stated, "Yes." MORGAN stated that he had a Visa Debit card in his wallet that he wanted to use.  I again attempted to ask MORGAN why he had refused to leave, MORGAN stated, "I did not."

Throughout my conversation with MORGAN he struggled to form coherent sentences.

I attempted to obtain MORGAN's address and phone number. MORGAN stated that he did not have a home, I asked if he was homeless and he stated, "I guess."

MORGAN voluntarily submitted to a portable breath test which resulted in a BrAC of .249.

I transported MORGAN to Littleton Hospital to receive a medical clearance prior to taking him to detox. While at the hospital the Nurse Practitioner was concerned that MORGAN could be suffering from a medical condition brought on by his high level of intoxication and chose to admit him for monitoring.

I left MORGAN in the care of Littleton Hospital staff.
