WHEREAS , Ordinance No. 18, Series of 2017 amended the annual appropriation for municipal purposes for the City of Littleton, Colorado; and
WHEREAS , appropriations have theretofore been made for the expenditures of monies pursuant to said budget; and
WHEREAS , the necessity of receiving and expending additional monies from the various funds could not have been reasonably anticipated during the time of adoption of the budget and appropriation of funds in accordance therewith;
NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF LITTLETON, COLORADO, THAT:
Section 1: The budget of the City of Littleton for the fiscal year beginning January 1, 2017, and ending December 31, 2017, is hereby amended by additions to the following funds:
