28	THE CITY OF LITTLETON, COLORADO, THAT:

30	Section 1: The budgeted expenditures for the Emergency Medical		
31	Transportation Enterprise for the period January 1, 2017, to December 31, 2017, are hereby		
32 33	amended to \$4,327,110.		
34	Section 3: Severability. If any part, section, subsection, sentence, clause or		
35	phrase of this ordinance is for any reason held to be invalid, such invalidity shall not affect the		
36	validity of the remaining sections of this ordinance. The City Council hereby declares that it		
37	would have passed this ordinance, including each part, section, subsection, sentence, clause or		
38	phrase hereof, irrespective of the fact that one or more parts, sections, subsections, sentences,		
39	clauses or phrases may be declared invalid.

41	Section 4: Repealer. All ordinances or resolutions, or parts thereof, in		
42	conflict with this ordinance are hereby repealed, provided that this repealer shall not repeal the		
43	repealer clauses of such ordinance nor revive any ordinance thereby.
