9 **AN ORDINANCE AMENDING THE 2017 EMERGENCY**
10 **MEDICAL TRANSPORTATION ENTERPRISE BUDGET**

13 **WHEREAS**, the city council established the City of Littleton Emergency
14 Medical Transportation Enterprise (the “Enterprise”) by Ordinance No. 15, Series of 2000; and

16 **WHEREAS**, the city council, as the governing board of the Enterprise, has the
17 authority to establish the budget for the Enterprise; and

18
19 **WHEREAS**, Ordinance No. 32, Series of 2016, established the 2017 budget for
20 the Emergency Medical Transportation Enterprise; and

22 **WHEREAS**, the necessity of receiving and expending additional monies from the
23 Enterprise could not have been reasonably anticipated during the time of adoption of the budget
24 and appropriation of funds in accordance therewith;

27 **NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF**
28 **THE CITY OF LITTLETON, COLORADO, THAT:**

30 **Section 1:** The budgeted expenditures for the Emergency Medical
31 Transportation Enterprise for the period January 1, 2017, to December 31, 2017, are hereby
32 amended to \$4,327,110.

34 **Section 3:** Severability. If any part, section, subsection, sentence, clause or
35 phrase of this ordinance is for any reason held to be invalid, such invalidity shall not affect the
36 validity of the remaining sections of this ordinance. The City Council hereby declares that it
37 would have passed this ordinance, including each part, section, subsection, sentence, clause or
38 phrase hereof, irrespective of the fact that one or more parts, sections, subsections, sentences,
39 clauses or phrases may be declared invalid.

41 **Section 4:** Repealer. All ordinances or resolutions, or parts thereof, in
42 conflict with this ordinance are hereby repealed, provided that this repealer shall not repeal the
43 repealer clauses of such ordinance nor revive any ordinance thereby.

46 INTRODUCED AS A BILL at a regularly scheduled meeting of the City Council
47 of the City of Littleton on the 5th day of December, 2017, passed on first reading by a vote of 5

FOR and 0 AGAINST; and ordered published by posting at Littleton Center, Bemis Library, the
Municipal Courthouse and on the City of Littleton Website.

PUBLIC HEARING on the Ordinance to take place on the 19th day of December,
2017, in the Council Chamber, Littleton Center, 2255 West Berry Avenue, Littleton, Colorado,
at the hour of 6:30 p.m., or as soon thereafter as it may be heard.
