### Littleton 2040: Vision to Comprehensive Plan Process

#### **CONSULTANT**

The primary consultant will provide professional urban planning and community/leadership engagement services to facilitate a highly-inclusive and wide-ranging Littleton 2040 Vision process and build upon the Vision process outcomes and framework to prepare an updated Comprehensive Plan for guiding the long-range development and redevelopment of the city. A Transportation Master Plan will also be developed in close coordination with the relevant aspects of the Comprehensive Plan process. Lastly, the consultant will assist the City in completing needed updates to its development regulations and standards to align with the guidance and direction set by the Littleton 2040 Vision process.

The City's designated project director will manage the overall process and direct consultant in performing the project services. The consultant will build upon and coordinate with other recent and concurrent planning efforts and studies to complete these tasks, and will coordinate with other agencies and entities, as appropriate, in conjunction with the City.

The consultant will coordinate with the City to establish a detailed and feasible project schedule for the execution and completion of the initial Vision process within **nine months** and then work toward official consideration of a final proposed Comprehensive Plan within another **13 months**, leaving two months for final public hearings and consideration of plan adoption within an overall **two-year timeframe**. The consultant will coordinate with City officials and staff to meet this timeline and include the Transportation Master Plan. Special are plans and code updates will occur both concurrently with and subsequently to this process.

- Arrange engagement activities at local schools geared toward specific grade levels and age groups

- Obtain and review the results of all recent public engagement activities or community surveys
- Compile all available vision/mission statements from public agencies and other community and non-profit organizations in or relevant to Littleton, as well as vision and goals and other aspirational statements in recent completed plans and policy documents (e.g., adopted City budget), to identify common themes, values, and priorities, as well as potential contradictory aspects
- Complete initial community mapping and build a photographic library that captures the visual, locational, and "3D" aspects of the Littleton 2040 Vision themes, issues, hopes, and concerns

- Meet with key public agencies and regional entities that contribute to the planning context
- Conduct engagement activities targeted to members of Littleton's "daytime population"
- Arrange a guest/expert speaker series to build an educational component into the Littleton 2040
   Vision process and to lend outside perspective on key community opportunities and challenges,
   highlighting that Littleton is not alone in tackling such issues and needs, and to provide
   "benchmarking" examples of successes and lessons learned elsewhere
